19 this Court:

20 CHARLES BRIDGES has committed the crime of one (1) count of THEFT IN THE AMOUNT
21 OF \$100,000.00 OR MORE, a category "B" felony in violation of NRS 205.0832, NRS 205.0835(e). All
22 of the acts alleged herein have been committed or completed on or between February 2, 2018 to August
23 31, 2021, by the above-named defendant, within the County of Clark, State of Nevada, in the following

1 **COUNT I**
2 **THEFT IN THE AMOUNT OF \$100,000 OR MORE**
3 **Category "B" Felony - NRS 205.0832, NRS 205.0835(e)**

4 Defendant CHARLES BRIDGES, did without lawful authority knowingly control property of
5 another person with the intent to deprive that person of the property, with the value of said property being
6 \$100,000.00 or more, to wit:

7 On or between February 2, 2018, through August 31, 2021, Defendant personally or through the
8 actions of another taken at their direction, knowingly obtained benefits from the Division of Welfare and
9 Supportive Services (“DWSS”) by fraudulently applying for Supplemental Nutritional Assistance
10 Program (“SNAP”) benefits and/or medical assistance (“SNAP/MED”) in various individuals’ names,
11 through DWSS’s computer system, in order for Defendant to personally and/or fraudulently use said
12 benefits with the intent to deprive DWSS of its property or services, with the aggregate total loss of
13 benefits being \$100,000.00 or more.

14 All of which constitutes the crime of THEFT IN THE AMOUNT OF \$100,000.00 OR MORE, a
15 category “B” felony, in violation of NRS 205.0832 and NRS 205.0835(e).
