1. **Call to order, roll call of members, and establish quorum.**

2. **Introduction of Peter Keegan, Deputy Attorney General (Keegan).
Introduction of members of the public and public comment.**
 - General Laxalt introduced Keegan. Keegan will be taking Brett Kandt's place as legal advisor to the Council.
 - **Public Comment:** There was no Public Comment.

3. **For Possible Action: Review, amend, and approve minutes from the November 9, 2015, meeting.**
 - A name was misspelled and that will be corrected. A Motion and Second to approve the minutes were made. The Motion passed, and the minutes were approved.

4. For Discussion and Possible Action: Vote to amend and approve the Bylaws.

- Keegan discussed the edits to the Bylaws. These changes were made by Brett Kandt. The changes include:
 - Including the Eleventh Judicial District
 - Removal of requirement for Council members to serve on at least one committee
 - Removal of the one-month notice for amending the Bylaws
- Member Patricia Lynch (Lynch) stated that she opposed the removal of the one-month notice at the previous meeting. She also questioned if the amended Bylaws were sent at least one month prior to this meeting. Keegan explained that under NRS Chapter 241, the one-month notice was not required. General Laxalt clarified that the "process to change the process" was not followed, but it does not have to be followed. Keegan stated that the meeting and Bylaws were posted over a week in advance. Lynch wanted to know why the Bylaws were not complied with. Keegan was under the impression that the Bylaws were reviewed at the previous meeting, although he was not there. Lynch said that the Bylaws were discussed, but the Council did not have a copy of the amendments at that time. Keegan proposed that if the Council wishes, this item could be continued to the next meeting so the members have the proper amount of time to review the Bylaws. Patricia Cafferata (Cafferata) agreed with Lynch that there should be notice before the meeting. General Laxalt said that this agenda item could be moved to the next meeting and that receiving the Bylaws at this meeting would be considered as notice. Member Mark B. Jackson (Jackson) motioned to table this agenda item to the next meeting. There was a second. The motion carried.

5. For Discussion and Possible Action: Nevada Arrest and Protection Advocacy Project (NAPA) Work Plan (Member Sue Meuschke (Meuschke)).

- Meuschke explained her grant-funded project. This grant funds victim advocates in the state. She also explained a second objective is creating a working group "to identify existing barriers and develop recommendations for improvement." The third objective involves "developing best practice recommendations for arrest and prosecution of domestic violence cases."
- Meuschke asked the Council for support of her organization's project and volunteers for the working group.
- General Laxalt asked Jackson if this project was similar to any project being done with any of the other Committees. Jackson stated that there

was a lot of crossover but there is nothing the same as this project.

- Staff member Joelle Gutman (Gutman) asked how the various Committees and people involved will be able to share information and communicate because "projects get siloed." Meuschke said that is what the working groups would help with.
- General Laxalt wanted to know if this project would be something that the Council sees as a primary project or a project to adopt.
- Meuschke stated it would be great if the Council endorsed and became part of the project. She would also like some Council members to volunteer their time, outside of the Council, to be part of the working group.
- Jackson motioned to endorse the project. There was a second. The Motion carried.

6. **For Discussion: Executive Director of Peace Officers Standards and Training (POST) to discuss current training related to domestic violence and possible opportunities for additional training for cadets and officers (Executive Director Mike Sherlock (Sherlock)).**

- Sherlock gave a brief introduction of himself and explanation of his credentials.
- Sherlock explained the various domestic violence laws in the country and in the state. He compared the Nevada law to the laws in California. He stated the Nevada laws were too broad and that makes it hard for officers enforcing the law. He said the law needs to be more "black and white" and less "watered down." He gave examples of things in the Nevada domestic violence law that should not be included in domestic violence (stalking, carrying a concealed weapon, child abuse, and sibling violence). He stated that domestic violence counts as a misdemeanor and explained the rules and laws which are confusing for law enforcement. He stated that domestic violence should be considered a felony. He believes that if the laws are focused and "cleaned up" that it would reduce domestic violence.
- Sherlock explained other issues with training law enforcement officers, like how to ask the right questions, understanding what a primary aggressor is, and arresting the victim because of battery.
- Member Suzanne Ramos asked if having more added to the domestic violence laws in Nevada would be helpful for law enforcement. Sherlock said that there should be less. Ramos inquired about his answer and Sherlock said that the law needs to be as clear as possible for the officers.

Meuschke asked for clarification of his answers as well.

- Jackson explained that the laws are created more around the larger counties in Nevada, but POST is centered on the rural counties. He gave examples of the history of his county (Douglas) and domestic violence, along with how his community works together on domestic violence cases. He stated his opinion that the Nevada domestic violence laws are very comprehensive.
- Meuschke asked Sherlock to supply the Council with the kinds of training that POST has. She also asked if there are any mandated hours, topics, if the trainings are the same throughout the state, etc.

7. For Discussion: Discussion regarding adding Human Trafficking Advocates and College Campus Advocates to the list of advocates to enable them to claim privilege if their records are requested by the courts (Member Elynn Greene (Greene)).

- Greene stated she was doing fact finding on Human Trafficking Advocates and wanted to bring this up to the Council and get input since it is such a diverse group.
- Jackson said that this is a new topic in the state. He believes that the victims should be able to go to any advocate, not just ones recognized by the statute.
- General Laxalt asked if there are any other examples for a different type of crime where a non-profit gets this status. Greene said that domestic violence and sexual assault advocates, community-based organizations that complete a minimum of 20 hours of training, qualified for privilege and confidentiality. She also said human trafficking advocates deal with both domestic violence and sexual assault.
- Member Christine Jones Brady asked what colleges/universities would be covered (public, private, etc.), and Gutman said she thought it would cover all higher education.
- Meuschke said it would be good to talk to university lawyers regarding privilege, community based advocates, and system based advocates. She said there needs to be a conversation between private and public non-profits and confidentiality.
- Greene said for the human trafficking side, she was looking specifically at the non-profit organization as they are written for human trafficking. Gutman asked if the victim definition could be changed to add human trafficking.

- Meuschke raised a question about prosecution and human trafficking. She stated that this should be addressed.
 - General Laxalt said that the Attorney General's office should look at this.
 - Lynch said it would be a good idea to continue this to the next meeting so this can be reviewed and discussed by the Attorney General's office, the District Attorneys, and others involved.
 - Meuschke stated that there needs to be a follow up with the campuses as well.
 - General Laxalt clarified that system advocates are not included. Meuschke said that college advocates work for a system and they would be system advocates. General Laxalt said it would be easier to add a new category (college advocates).
8. **For Discussion: Update regarding revisions being made to Domestic Violence Prosecution Best Practice Guidelines and Model Policy Standard Operating Procedure for the Enforcement of Protection Orders against Domestic Violence (Gutman).**
- Gutman brought this forth to the sheriffs and law enforcement throughout the state. She also brought this to the law enforcement summit in Elko. She has not had a lot of feedback, but Jackson will be assisting her in getting this to the right people. She would like to present this to the Council when she finishes a final draft.
 - Cafferata said that Liz Greb, Grants Manager at the Attorney General's office, might have some money to help with this project and to touch base with her.
 - Gutman asked for any feedback to be sent to her.
 - Jackson stated that these best practice guidelines were created by the Nevada Advisory Council for Prosecuting Attorneys (chaired by General Laxalt), and that is why it mentions an endorsement. Any suggestions by this Council will likely result in the guidelines stating an endorsement by the Nevada Council to Prevent Domestic Violence.
 - Gutman said that this process could potentially take a year or more.
 - Lynch and Gutman both agreed on the possibility of a working group for this project.

9. **For Discussion: Update about possible items to be included on BDR for 2017 Legislative Session (Gutman).**

- **County Assessor/Property**

- Gutman spoke with Mike Sheers, the president of the County Assessors, regarding the exclusion of addresses of members of the Confidential Addresses Program (CAP) from public records that the county assessors have.
- She stated right now there are no regulations regarding CAP members and was wondering if this needs to happen now because people are being legally protected.
- She contacted the county recorder's office and they said that no one is protected and public records are available there. They discussed a possible flagging system for victims.
- Meuschke brought up how easily accessible documents are online and the county recorder's office is available online.
- Gutman and Keegan will be talking to the county assessors about this in April.

- **Next of Kin Law related to murder in Domestic Violence cases**

- Gutman and Greene gave a brief history of "Veronica's Law".
- Gutman explained the statutes for Nevada, California, and Arizona regarding next of kin.

GENERAL INFORMATION

VINE is a free and anonymous service that provides victims of crime and the persons who serve them with two important features: Information and Notification. The Nevada Statewide VINE service is provided by the Nevada Office of the Attorney General by a grant from the US Department of Justice, Bureau of Justice Assistance.

VINE monitors the custody status of offenders in the county jails as well as the department of corrections. The information is stored at the VINE Communication Center in Louisville, KY. Information is available 24 hours a day, 365 days a year.

The Nevada Statewide VINE system is available in *English and Spanish* and is supported by *24-hour operator* assistance. Simply dial 1-888-268-8463 and "0" out to an operator at any time during the call.

DATA TRANSFER SCHEDULE

Detention Center, Department of Corrections:

Every 15 minutes, 24 hours a day, 7 days a week

INFORMATION

Anyone may call the Nevada Statewide VINE service to determine the custody status of an offender. Callers will need a touch-tone telephone to use the service. To search for an offender through the VINE system, callers will need to provide the system with one or more of the following items:

- Offender Name or Alias
 - Secondary search options if there is more than one offender with the same name:
 - Date of Birth
- Offender Number

Information provided when calling the VINE system:

- Current Offender Custody Status
- Offender Name (if searched by number)
- Offender Number (if searched by name)
- Name of Facility

REGISTRATION

For custody status or court event change notifications, crime victims and the general public may *register directly with VINE by calling the VINE toll-free number 1-888-268-8463 using a touch-tone telephone or going online at www.vinelink.com. Upon locating the offender, the caller will need to provide the following information in order to register for notification:

- A telephone number, including area code, where they can be reached.
- A 4-digit Personal Identification Number (PIN).

***If a registered person moves or changes their phone number, they must update their telephone information by calling the VINE line at 1-888-268-8463.**

NOTIFICATION

Notification messages will be left on an answering machine, but calls will continue every 2 hours for 48 hours. ***In case of transfer to other facility notification calls will be delayed for eight (8) hours from the time the transfer record is received by the VINE service.***

Caller ID

NOTE: For telephones with Caller ID or Anonymous Call Block--a notification call from VINE will show up as a telephone number with a "502" area code. This number will not be answered when called, but is only used for purposes of getting the notification through when anonymous calls are blocked.

NRS 228.205 Victim Information Notification Everyday System: Creation; appointment and duties of Governance Committee; gifts, grants and donations; cooperation of certain state and local agencies; no cause of action by victim of crime established by failure of System.

1. There is hereby created in the Office of the Attorney General the Victim Information Notification Everyday System, which consists of a toll-free telephone number and an Internet website through which victims of crime and members of the public may register to receive automated information and notification concerning changes in the custody status of an offender.

2. The Attorney General shall:

(a) Appoint a subcommittee of the Nevada Council for the Prevention of Domestic Violence created by NRS 228.480 to serve as the Governance Committee for the System; and

(b) Consider nominations by the Council when appointing members of the Governance Committee.

3. The Governance Committee may adopt policies, protocols and regulations for the operation and oversight of the System.

4. The Attorney General may apply for and accept gifts, grants and donations for use in carrying out the provisions of this section.

5. To the extent of available funding, each sheriff and chief of police, the Department of Corrections, the Department of Public Safety and the State Board of Parole Commissioners shall cooperate with the Attorney General to establish and maintain the System.

6. The failure of the System to notify a victim of a crime of a change in the custody status of an offender does not establish a basis for any cause of action by the victim or any other party against the State, its political subdivisions, or the agencies, boards, commissions, departments, officers or employees of the State or its political subdivisions.

7. As used in this section:

(a) "Custody status" means the transfer of the custody of an offender or the release or escape from custody of an offender.

(b) "Offender" means a person convicted of a crime and sentenced to imprisonment in a county jail or in the state prison.
