  - c) Traci mentions the attendance of Jeff LaRosa via tele-conference. Jeff LaRosa introduced himself as Manager of Client Relationship Team for

Appriss. His team is responsible for the maintenance and retention of VINE services from an Appriss perspective.

- 3. Discussion, review and approval of minutes from March 1, 2016, VINE Service Sub-Committee meeting. (For possible action.) Attachment 1
  - a) Traci calls for motion to approve a minutes. Robert motioned to accept. Maxine seconded. No discussion. All in favor. Motion carried.
- 4. Introduction of new Ombudsman Arlene Rivera (Rivera) who will also provide an update on current and future VINE service funding.
  - a) Arlene introduced herself to the committee and her role as DV Ombudsman.
  - b) She stated we are still looking for ways to gather funding for VINE, other areas covering domestic violence, and human trafficking.
  - c) In regards to VINE funding, the Victims of Crime Act (VOCA) is a sub grant from Nevada Division of Child and Family Services currently paying for enhancements to VINE in the amount of \$243,000. As far as maintenance, all jurisdictions are invoiced for their annual amount.
    - i. Henderson is an exception as they are invoiced monthly.
    - ii. The expectation is continue using this grant for funding in regards to the VINE contract.
- Presentation by a representative of the Attorney General's office regarding Senate Bill 25. Attachment 2
  - a) Traci requested Item 5 be added to the agenda as part of the bill affects the makeup of the VINE committee.
  - b) The presentation will be revisited as the presenter makes their way to the meeting.
  - c) Brett presents an overview of SB 25 which deals the AGO's functions and responsibilities in regards to victim's service, especially domestic violence.
    - i. He describes the wide range of function and responsibilities within the office due to different administrations.
      - 1. Grant funding helps provide funding for committees.
      - 2. The Certification of Batterer's Treatment programs was created under AG Papa.
      - 3. NCPDV was created under AG Sandavol.
      - 4. DVFRT and VINE project was created under AG Masto.
  - d) He states that the bill affects the committee as it seeks to merge all committees into a super committee, except VINE unless amendments are made.
  - e) Traci stated this item will be put on the next agenda for discussion.
