1. **Call to Order and Roll Call.**
2. **Public Comment.** Discussion only. Action may not be taken on any matter brought up under this agenda item, until scheduled on the agenda of a future meeting for possible action.

Heather Proctor asked about the notifications for Marcys Law requesting confirmation that the District Attorneys will comply with the requests and assist her unit with records. Jennifer Noble confirmed that the Washoe County DA office has complied.

3. **Attorney General Aaron Ford's Welcome. Self-introduction of members present.** Attorney General Aaron Ford welcomed the members, and everyone introduced themselves.

4. **Discussion and for possible action to approve the April 16, 2019 meeting minutes.** *(Agenda Item No. 4)*
Arthur Mallory moved to approve the minutes from April 16, 2019. AJ Delap seconded the motion, and it passed unanimously.
5. **Authorization to proceed with contracting and further planning of 2019 Prosecutors Conference.**
Kyle George reported that the 2019 Nevada Prosecutors Conference is set for September 11, 2019 through September 13, 2019, at the Hilton Lake Las Vegas, Las Vegas, NV. Mr. George would like approval to enter into contract with the Hilton and to take all other actions necessary to plan this event. Robert Sweetin brought the motion, Arthur Mallory seconded. No discussion motion passed unanimously.
6. **Discussion of 2019 Raggio Award. (Discussion only).** Discussion on nomination and selection process for recipient of 2019 Raggio Award, to be awarded at the 2019 Prosecutors Conference. Kyle George, First Assistant Attorney General, Office of the Attorney General asked for guidance on how the selection process was conducted in the past and how the nominations were submitted. Steve Wolfson stated that in the past it was done on a North-South rotation but asked if possible to have 2 people receive the award. AG Ford suggested that all nominations be submitted to Kyle George, First Assistant Attorney General by close of business July 5, 2019. Once all the nominations are received, a teleconference meeting will be held to vote.
7. **Discussion of Upcoming Human Trafficking Summit. (Discussion only).** Discussion of upcoming Office of the Attorney General Human Trafficking Summit rescheduled for October 6, 2019 through October 10, 2019. Nicole O'Banion, Domestic Violence Ombudsman was present and was very excited about the speakers that have volunteered to attend and present without charging a fee. The presenters are from various other law enforcement agencies and entities across the country and they are the innovators and creators of the Sex Buyers Initiative that has a holistic approach to reducing the demand, it is addressing all sides which includes treatment for offenders, services for victims and innovative solutions to keep the programs running. AJ Delap asked if the summit is open to all Law enforcement and then offered to help get the word out to LVMPD. Jessica Adair complimented Nicole O'Banion for diligently working on the trafficking summit. The summit will be open to all Prosecutors and Law Enforcement and is a free event.
8. **Post-Session Legislative Update (Discussion only).** An update on the 2019 Legislative Session and the impacts on the criminal justice system or local governments. John Jones, Office of the Clark County District Attorney/Nevada District Attorneys Association, and Jennifer Noble, Washoe County District Attorney's Office update members on the Legislative bills that passed and failed in the 2019 Legislative session.
9. **Closing Remarks. (Discussion only).** Aaron Ford, Nevada Attorney General commended Jenny Noble and John Jones, Jr for their efforts this Legislative session.
