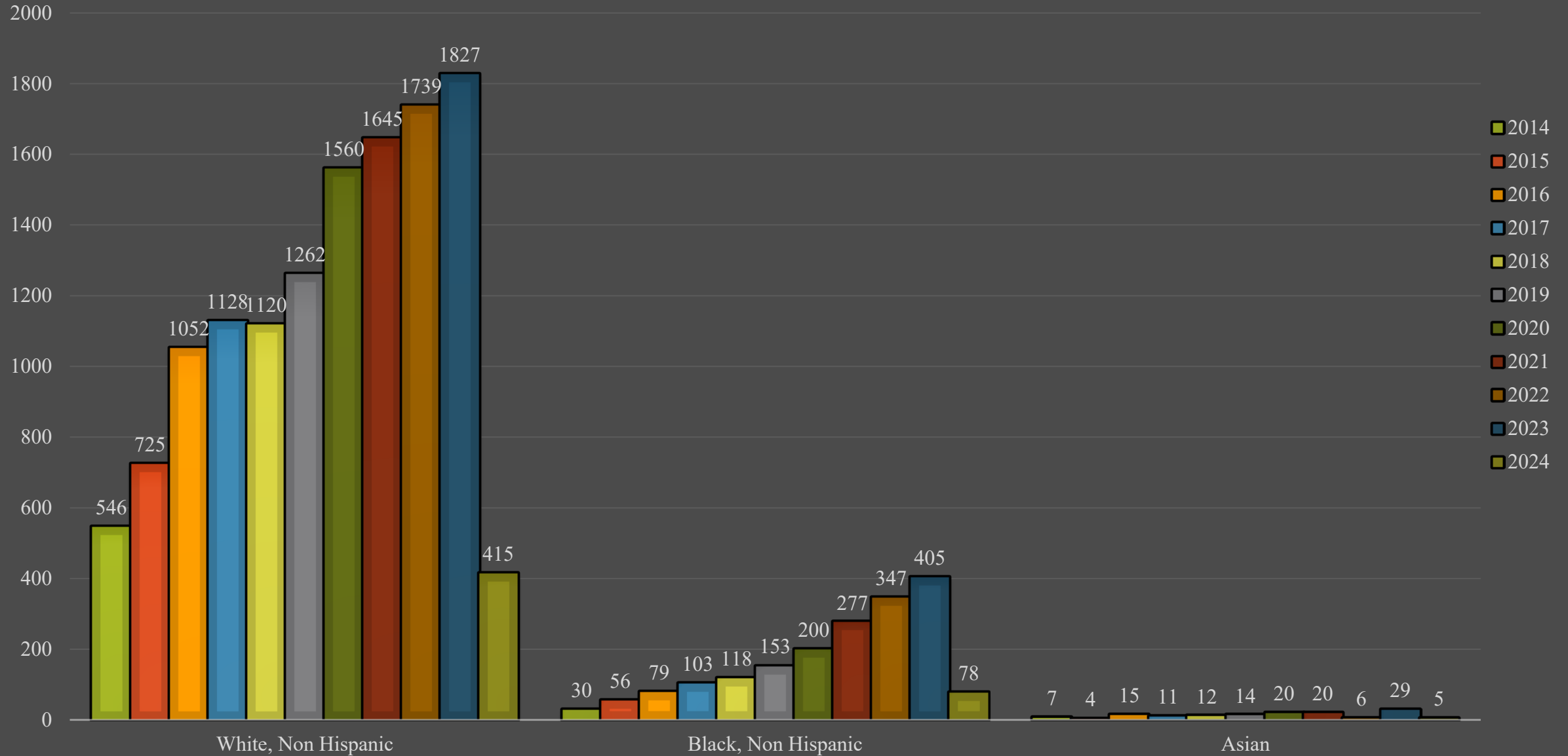

- *Life saving and life altering effects*

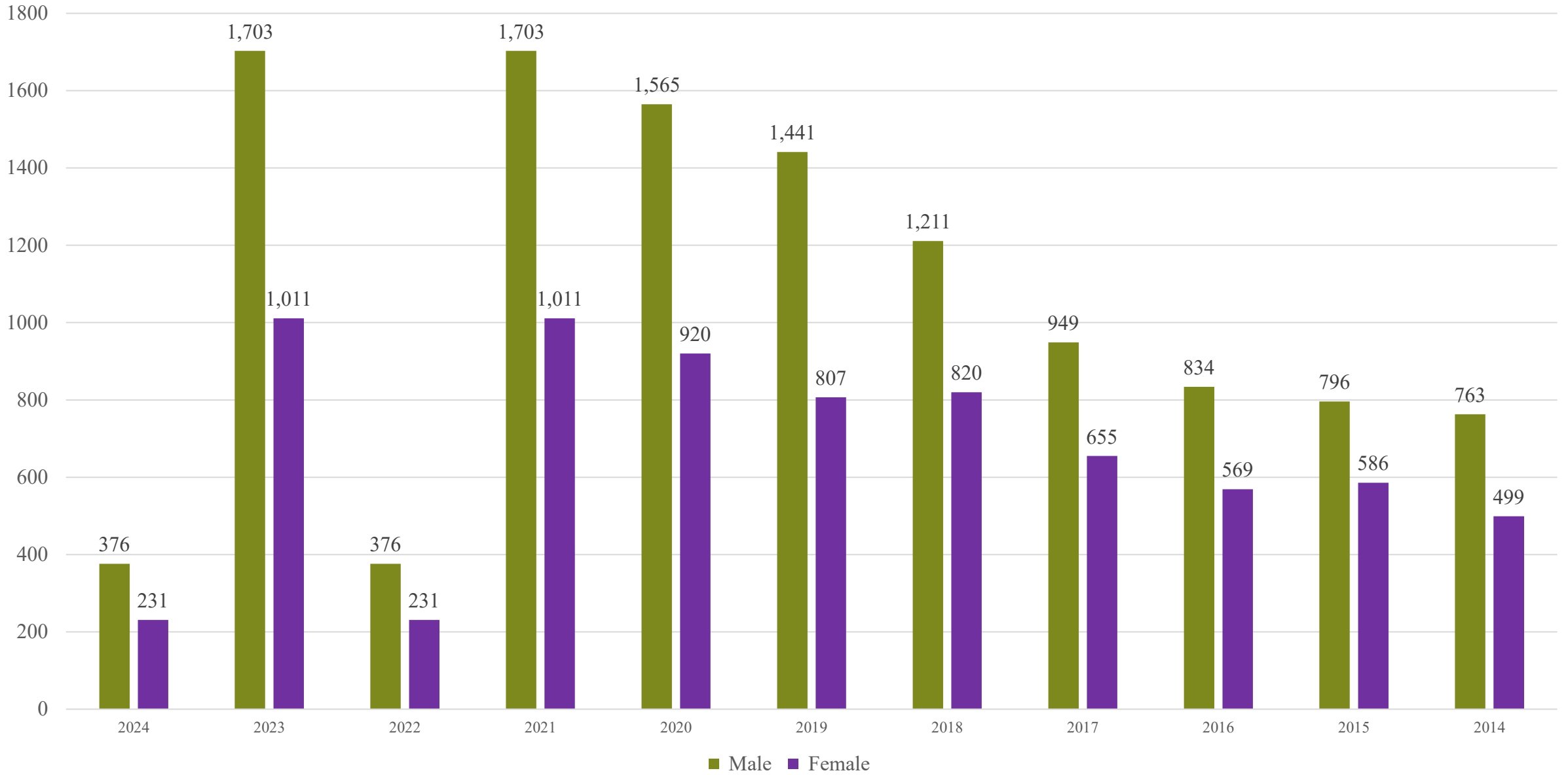
Special Populations

Narcotic Related Deaths by Population



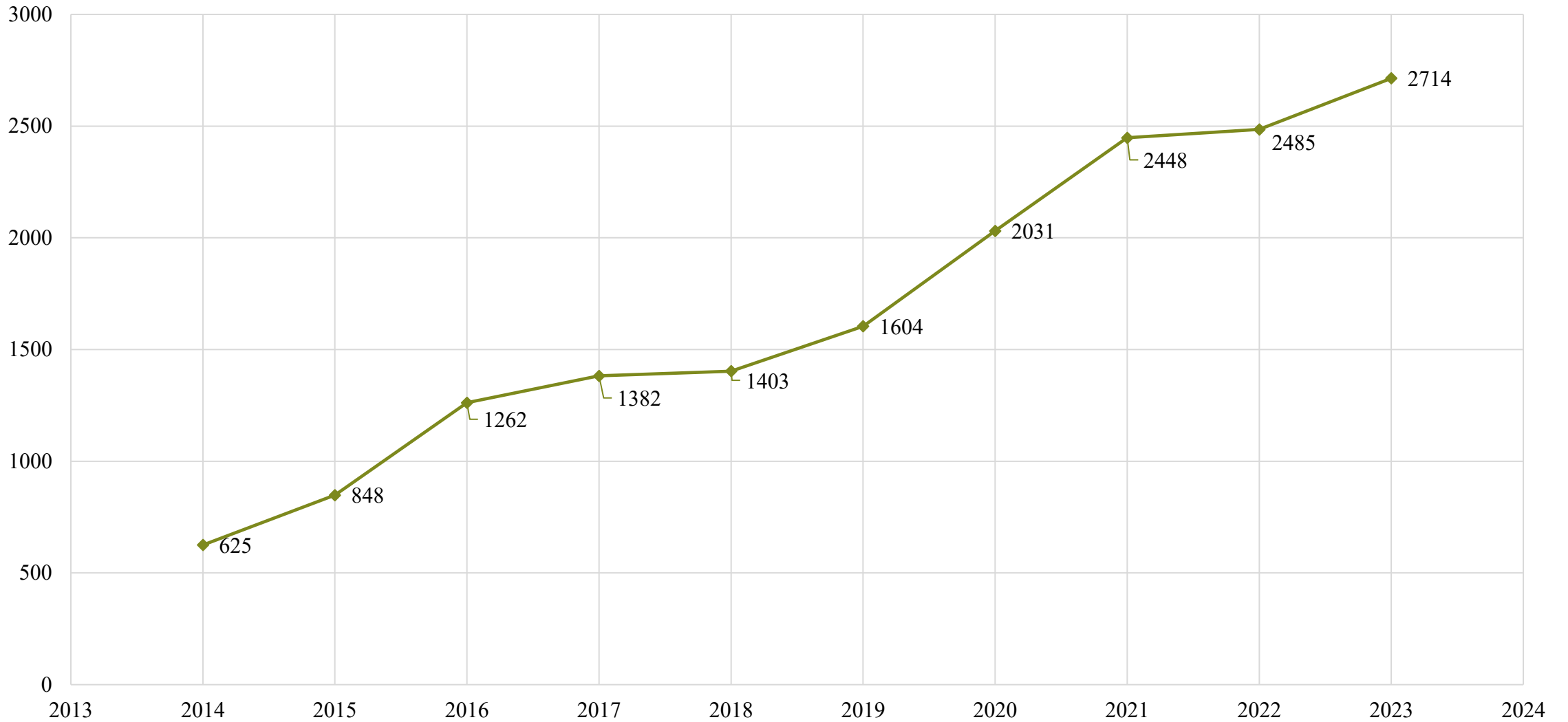
Death by Drug Intoxication Relative to Gender



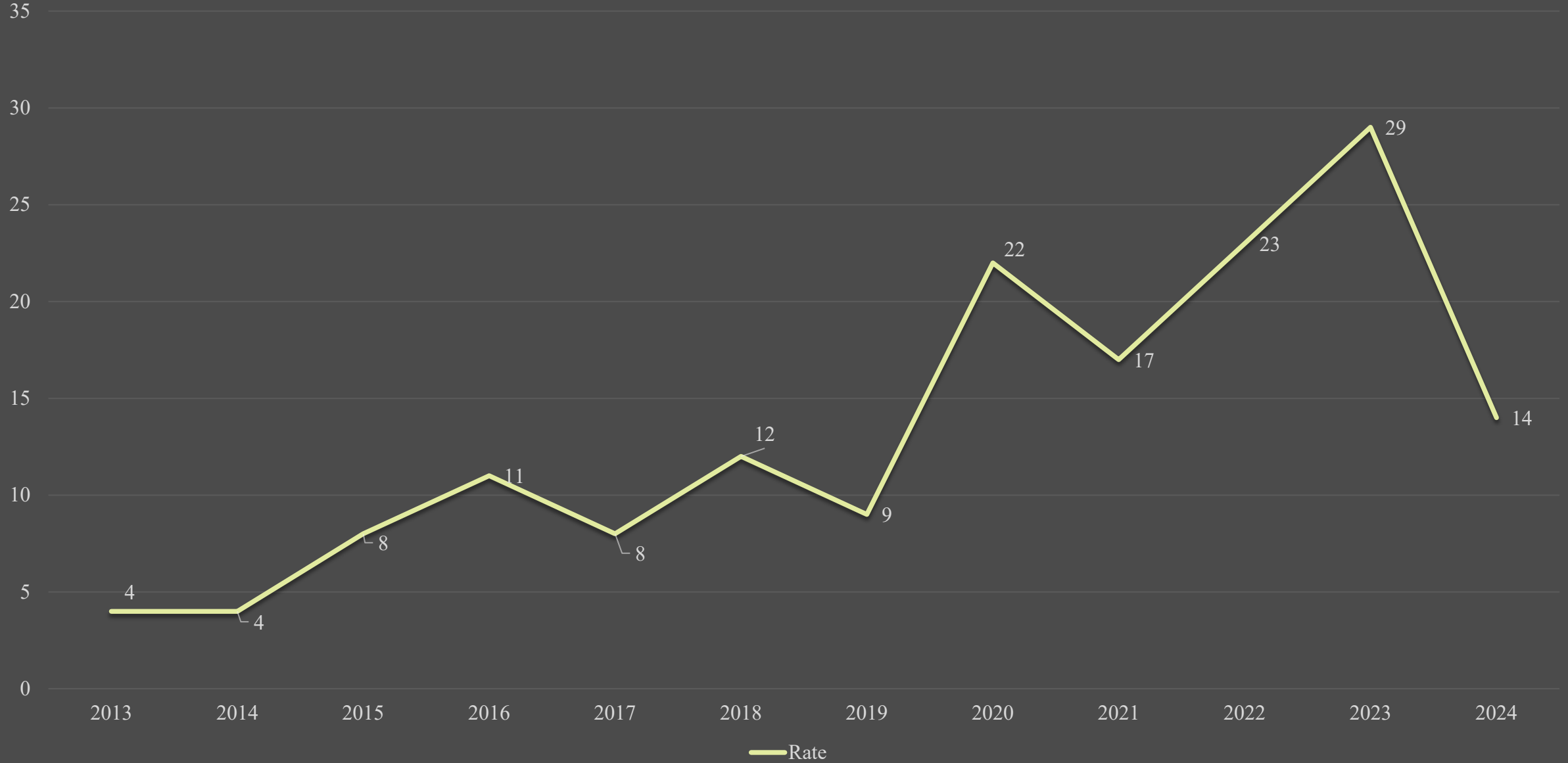

Effects on Organ Systems

- Depending on the drug, each has considerable consequences leading to slight or complete dysfunction in the organ system. Some are irreversible leading to non utilization of the consented life saving gift.
- Organ suitability is evaluated based on the cause, circumstance and mechanism of death while also taking into consideration patients health history.
- Long term drug use can cause serious issues such as cardiomyopathy, vegetation on the heart, arrhythmias, oxygen deprivation, cirrhosis and worse, complete organ failure.

Gaps

- *Treatment for a diverse population – Most groups focus on one population, while it is evident that this epidemic is spread throughout all populations.*

Recommendation(s)

- *We would recommend additional funding and resources be considered for those who are left behind by those who succumb to this epidemic.*
 - *Examples include grief counseling, treatment facilities, family support groups and contributions to local charities supporting survivors to help them find their voice.*
- *Nevada Donor Network's After Care program focuses on the loved ones of Organ, Eye and Tissue donation by providing said resources, support groups and outreach for a minimum of 2 years post donation.*

It was noted at the March 25, 2024 Response Subcommittee Meeting that the following legislative component had not been addressed in any of the 2023 recommendations:

- *(l) Evaluate current systems for sharing information between agencies regarding the trafficking and distribution of legal and illegal substances which are associated with substance use disorders, including, without limitation, heroin, other synthetic and non-synthetic opioids, and stimulants.*

LAPPA Next Steps Based on Survey & Discussion at April 10, 2024 SURG Meeting

The LAPPA 2023 State of the States Legislative Roadmap for Reducing Overdose Deaths and Increasing Access to Treatment identifies four strategies that Nevada has not adopted. This included the following which have been assigned to the Response Subcommittee for review:

- Require state and local correctional settings to provide withdrawal management services
 - Members supported this with a note that some jurisdictions do support withdrawal management in correctional settings; another member thought there was proposed legislation in the last session. One member noted agreement as long as it does not come in the form of an unfunded mandate.
- Support information sharing with overdose fatality review teams
 - Members agreed with this.
 - The state OD2A group did a [report](#) on this and described their recommendations/successes/barriers.

Recommendations Received and Next Steps

- **Recommendation #1:** Recommend a BDR to have recidivism defined in NRS
- **Submitted by:** Dr. Terry Kerns
- **Justification:** Recidivism is the act of committing another crime or coming into conflict with the criminal justice system (CJS) again. It is an important measure of the effectiveness of CJS efforts to promote rehabilitation, reintegration, and public safety. Recidivism rates are not available at a national level 1 since there is no national consensus on the operational definition of recidivism and there are significant variations in how recidivism is defined and counted (e.g., re-contact, re-arrest, re-incarceration, or reconviction) in different jurisdictions. For this reason, comparisons between studies and jurisdictions should not be made. (Recidivism in Criminal Justice, <https://www.justice.gc.ca/eng/rp-pr/jr/jf-pf/2020/aug01.html>). The Nevada Department of Corrections defines recidivism as a return to incarceration with NDOC within 3 years of an offender's date of release.
