Some educational materials also requested.	\$ 44,284.00
Winnemucca Domestic Violence Shelter	Humboldt County	Dual services (DV) agency will recruit and hire FTE .50 dedicated Sexual Assault Advocate to provide services such as accompaniment, shelter, and other financial support of victims in Humboldt and surrounding areas. Funds are also requested for outreach materials and distribution.	\$ 21,818.00

The Shade Tree	Clark/LV County	Dual services (Homeless Women and Children) will add an additional FTE 1.0 Client Advocate to assist with caseload which includes significant co-occurrence of sexual assault/abuse (1,200/year). Family Support Council of Douglas County	Douglas County	Dual services (DV and Family Violence) will maintain advocate accompaniment and transportation cost to Pegel Center for 15 victims/year.
