The Committee on Domestic Violence, 5420 Kietzke Lane, Suite 202, Reno, Nevada, 775-688-1960, is proposing the Adoption, Amendment, and Repeal of regulations pertaining to Chapter 228 of the Nevada Administrative Code. A workshop has been set for 10:00 a.m., on August 15, 2013, at the Grant Sawyer State Building, 555 E. Washington Avenue, Room 4500, Las Vegas, Nevada, and Office of the Attorney General, 100 North Carson Street, Courtroom, Carson City, Nevada. The purpose of the workshop is to solicit comments from interested persons on the following general topics that may be addressed in the proposed regulations:

NAC 228.XXX – Adopting a definition for “indigent”
NAC 228.110 – Amending qualifications for supervisors of treatment and providers of treatment
NAC 228.115 – Amending language to clarify use of webcam supervision
NAC 228.XXX Adopting a new section pertaining to professional responsibility
NAC 228.130 – Amending language regarding timeline for submission of corrective action plans
NAC 228.175 - Amending language to clarify contents of written agreement between offender and provider
NAC 228.210 – Amending language to require continuing education in supervision topics
