Please Note: The Nevada Council for the Prevention of Domestic Violence Legislative Subcommittee may 1) address agenda items out of sequence to accommodate persons appearing before the Council or to aid the efficiency or effectiveness of the meeting; 2) combine items for consideration by the public body; and 3) pull or remove items from the agenda at any time. The Council may convene in closed session to consider the character, alleged misconduct, professional competence or physical or mental health of a person. See NRS 241.030. Prior to the commencement and conclusion of a contested case or quasi-judicial proceeding that may affect the due process rights of an individual the board may refuse to consider public comment. See NRS 233B.126.

At the discretion of the Chairman, public comment is welcomed by the Council. A period of public comment will take place at the beginning of the meeting and again prior to the adjournment of the meeting. The Chairperson may limit each speaker to 5 minutes, as time allows and at her/his sole discretion. Everyone who is interested in speaking will be given the opportunity to speak at either or both public comment periods.

Note: No vote may be taken upon a matter raised under public comment until the matter itself has been specifically included on an agenda as an item upon which action may be taken. (NRS 241.020)

  - <u>SB99</u> (BDR 14-134) filed by Senator Segerblom. Repeals provisions governing sex offenders which were originally enacted for the purposes of the federal Adam Walsh Act.
  - <u>AB49</u> (BDR 15-158) filed by the Committee on Judiciary. This bill revises provisions governing crimes.
  - <u>AB435</u> (BDR1-302) referred to Committee on Judiciary. This bill provides realignment of certain judicial districts.
  - <u>SB60</u> (BDR16-470) Filed by the Office of the Secretary of State on behalf of the Attorney General. Revises various provisions related to the office of the Attorney General. This bill affects the Confidentiality Address Program
  - <u>SB175</u> (BDR15-515) Filed by Senator Roberson. Revises provisions governing gun laws. This bill includes prohibition of a person convicted of domestic violence from owning or having custody of any firearm.
  - <u>AB214</u> (BDR16-568): Filed by Assemblyman Sprinkle. Revises provisions governing crimes relating to human trafficking and the Contingency Account for Victims of Human Trafficking.
  - <u>AB108</u> (BDR14-750) filed by Assemblyman Elliot Anderson. Revises provisions governing victims of sex trafficking.
  - <u>SB187</u> (BDR 3-871) Filed by Assemblyman Sprinkle. Revises provisions concerning the ownership possession and control of firearms by certain persons.
  - <u>AB193</u> (BDR14-911) Sponsored by Assembly Committee on Judiciary. Revises provisions governing the waiver of a preliminary examination. This bill affects how victims are questioned during preliminary and grand jury proceedings.
  - <u>AB212</u> (BDR 14-1062) Filed by Assemblywoman Bustamante Adams. Revises provisions relating to the crime of sexual assault.
  - Other bills that have not been identified.
