Ron Titus suggested summarizing some of the legislation that has been passed and sending a questionnaire requesting comments. Valerie Cooney brought up the training that was held for limited jurisdiction judges, and she wonders if through the questionnaire, they could find out if judges attitudes or opinons have changed. Sue Meuschke felt it would be helpful to include in the report, a survey on whether more victim services positions have been created in the rurals. She suggested speaking to Kareen Prentice to see what information has been collected in this area. Valerie Cooney directed the committee's attention to the elections that will take place soon, and the resulting number of new judges that may come to sit on the bench in these rural jurisdictions. There is currently no requirement for in depth training of these new judges on domestic violence - they receive training at the Judicial College, but only a small fraction of their time is spent on domestic violence issues. Sue Meuschke said she believes it currently amounts to about an afternoon of training. Sue Meuschke asked Ron Titus for a copy of the curriculum or syllabus of the Judicial College training for these limited jurisdiction judges. Mike Sprinkle asked that Ron Titus send a copy of the judges training to Melissa Page, Assistant to the Council, for her to email to all the committee members.

1. *Call to order, roll call of members, and introduction. Mike Sprinkle called the meeting to order at 10:00 a.m. A roll call was performed and guorum was established.

2. *Review and approval of minutes from May 30, 2008 meeting.

Brett Kandt made a motion to approve the minutes as submitted. Valerie Cooney seconded the motion. The motion passed.

3. *Discussion and Possible Action on Biennial Legislative Report

Kareen Prentice gave the Committee an Update. She reported that they had close to 40 Judges completed and returned the survey, and their comments are currently being typed. They should be done in a couple of days. She indicated the comments had been interesting, and she would have them ready for the Committee to look at for the next meeting. There were a couple of Judges that were concerned with the questions and felt that they were breaking laws by filling out the survey. They had contacted Assistant AG Munro regarding this, and he had discussed the matter with Kareen. The Questionnaire and Survey had been approved by both the Legislative Committee and Assistant AG Munro.

Mr. Sprinkle inquired as to the time line for a draft of the report. Ms. Prentice responded it is due in January, and September 8th is the next Council meeting. The report itself is due February 1, 2009, but they will have to present it to the entire Council prior to that time. Ms. Prentice mentioned the Council will have to meet in January so they can review the final document. She will have a draft ready for the September 8th meeting, but she did not know if the Committee members would have a chance to look at it prior. Mr. Sprinkle preferred that they be able to go through it in their committee first, so they can have something more formal. A Committee member stated she thought they would be more responsive if they have a review of the draft prior to the September 8th meeting. Ms. Prentice stated she would email a draft to each Committee member. Ms. Rasul suggested they have a meeting of a smaller group prior to September 8th. Mr. Sprinkle indicated he thought this would be more efficient that having 25 people at the larger meeting review the document. Then they could make just one presentation to the Council.

Ms. Rasul asked if they could have a Committee member volunteer to help Kareen with the draft. Valerie Cooney then offered to assist Kareen with the draft of the report. Mike Sprinkle asked if there were any other general thoughts as far as the body of the report goes as to what the Committee would like to have presented to the Legislature. He thought input on this matter would help Kareen. Sue Meuschke mentioned she thought they should put in whatever the legislation requires. Mike Sprinkle mentioned he thought they should give a synopsis of the rural meetings the Council has had over the last couple of years, and in a general sense some of the feedback that they have gotten at those meetings. That is an important issue to the legislators, that the Council is doing outreach to the rural communities. He suggested they also talk about some of the efforts they have made to get underrepresented persons on the Council. They have not been really successful, but at least they have been trying. Ms. Prentice agreed to include this information in her report. Ms. Rasul then thanked Ms. Cooney for agreeing to help her and Kareen with the report, and Ms. Cooney stated they should email her to let her know what they need in terms of getting together, etc.

4. *Public Comment

Dr. Yacenda stated he wished to make a comment as there is something they might want to consider as a Committee, or rather as the Council. He then referred to the forms they used in terms of policy considerations, and referred to two charts, (Abuse of Children, and Power and Control) stating that he had an item that would intersect those two charts. He suggested there is currently a major conflict in their elder abuse and their child visitation laws. The conflict states that we don't want to let elders be abused, exploited, isolated, or intimated, but we also have a visitation law that says that certain grandparents of certain families have no rights to ask the Court to help them see their grandchildren, whereas other grandparents do have that right. We have a conflict in the laws that says that depending on the nature of the family, whether it is intact, or nonintact, and a grandchild is involved, if they are from an intact family, the grandparents cannot ask the court if they can be in contact with their grandchildren.

He stated the long and short of it is that they have custody and visitation statutes that are in contradiction to elder abuse statutes, and that without changes to certain statutes, they have a situation where adult children can deny visitation rights to grandparents and great-grandparents. He also added he would leave the recommended changes with the Council, put together in the format required by the legislature, and that his contact information was on the documents.

5. *Discussion and possible action on Primary vs. Dominant Aggressor Issue

Mr. Sprinkle indicated that this issue was a general topic at their last meeting. Someone on the Committee was going to do some research into that topic. He asked if anyone wished to speak on this issue. Valerie Cooney indicated that Sue had given them the background and history on the issue. She did not remember that someone had offered to do additional research at this point in time, but that the minutes reflect that they were going to have this issue as part of the Visitation and Custody issues in DV awareness month in 2009. Mr. Sprinkle suggested they go ahead and not add this issue to further agendas. There was no further discussion of this item.

5. *Discussion and possible action on Sentencing Reform

Mr. Sprinkle mentioned this had been on the agenda for a few months Mr. Kandt reported that the Advisory Commission on the now. Administration of Justice will be meeting twice in August, the 18th and the 25th, to make some decisions on their legislative proposals. He did not know what they were going to be, or if any of them would specifically involve Domestic Violence. He stated Kareen Prentice is on the Subcommittee for Victim's Rights, and might have a better idea if that subcommittee is going to have any specific recommendations. He mentioned he had written a letter on behalf of prosecutors at the request of Justice Hardesty, that had strongly voiced objections to the impact of AB 510. It stated that in fact there is not truth in sentencing, and sentences are not accurately reflected any more, and that they want the Commission to take the position that at the time of sentencing a full and accurate disclosure of the impact of AB 510 on the sentence will be made to all parties. Ms. Prentice mentioned the Victims of Crime Subcommittee had just submitted three bill draft requests that they voted on, to the Advisory Commission for them to choose one, or not choose any. One of them is from the Victims of Crime Compensation, changing the time frame in which a victim can appeal a denied claim from 15 to 60 days, and a request for a new sexual assault protection order, because if there is not a dating relationship, if they know the person from the workplace or college, they cannot currently obtain a protection order. The third one is a revision to the Victims of Crime Compensation NRS that would allow them to keep the extra funds within the Victims of Crime Compensation above their authority, and not have it revert back to the general fund, so they can help more victims. Ms. Meuschke verified that was accurate.

6. *Discussion and possible action on any upcoming or pending Legislative Items

Mr. Sprinkle asked about the "Once A Felon, Always A Felon" BDR status with the AG Office. Mr. Kandt mentioned they did have the BDR request, and he had a copy of it. It had been shared with the Committee. He qualified his previous statement when he mentioned he did not know if the Attorney General had made a final decision as to which bills she is going to carry; the office is limited to 15 BDR's, and the office has a greater number of proposed BDR's than the limit. But, it is his understanding that Once a Felon, Always a Felon, will receive strong consideration to be one of the BDR's that is carried by the Attorney Mr. Kandt is fairly confident this will be part of the General's office. Attorney General's BDR package; he was certain she had made the decision to include it. He requested permission of the Chairman to mention one other matter. He had also authored a bill to amend NRS 200.481, which is the battery statute, to provide for battery by strangulation to be considered a felony, which he had worked on with Las Vegas Metro Police Dept. They had been planning to line up a

legislator to carry the bill but they had not done that. Heidi Gansert had approached him and asked if there was anything she could do to help; she was very interested and was meeting with LCB legal this week. She may be carrying this; and he would like the entire Committee to be on board. It was his understanding that there is widespread support for this bill. Mr. Kandt asked if everyone had seen the draft he did; several persons had not. He mentioned he would like to hear back from Heidi Gansert as to whether she was willing to carry it, then he would get back to the Committee regarding the matter, and would disseminate the materials accordingly. The Chairman asked if there was any further information anyone had on pending legislation. Ms. Meuschke mentioned there would be a bill proposing an increase to the marriage license fee to make up for the shortfall, Bernice Matthews would be carrying the bill. They are hoping to get a letter of support from the Council. Mr. Sprinkle mentioned if they could see the language, they would probably be able to do that.

He also stated that in his comments section at the next Council meeting he will be requesting the same thing he did a couple of years ago; that once they get closer to the legislative session, the BDR's will come through this Committee first. That does not mean the other council members are excluded, however. Ms. Meuschke mentioned there is a BDR for the creation of a Domestic Violence registry; she did not have the number of it, but it is under Assemblyman Ohrenschall. They have communicated with him that they would not support such a bill.

Ms. Meuschke mentioned it would not be good use of resources, there would not be good information included in it, and she did not know what the benefit to anyone would be. Mr. Kandt mentioned the fiscal costs associated with it pretty much doomed it from the start. Ms. Meuschke stated there are lots of issues. She thinks maybe once DPS gets some other things up and running, then maybe they could have a conversation about this. But, the problem is determining who is going to be in the registry, how you define things, and what the benefit would be. Mr. Kandt asked if this was being modeled after a registry in another state. Ms. Meuschke responded this would be the first one. There is currently a bill in the Pennsylvania legislature, and California just defeated a bill that would have created one in California. There was no further discussion under this topic.

7. *Schedule future meetings and agenda items

Mr. Sprinkle asked if they wanted to try and schedule a meeting before September 8th to go over the report. He asked Kareen if she thought she could have it done, and she replied in the affirmative. Mr. Sprinkle stated they would be looking at the first week in September. The meeting was scheduled for 9:00 a.m. on August 29, 2008. Mr. Sprinkle asked if there were any other agenda items anyone would like to see for the meeting, aside from the draft. He stated if anything comes to mind prior to that date to let him or Kareen know. Ms. Meuschke asked if in terms of the minutes they were going to discuss the summit on Visitation and Custody. She wanted to have that put on the agenda for the next meeting. Mr. Kandt suggested that for a little bit of specificity, they also add to the agenda for the next meeting a review of any legislative proposals from the Advisory Committee for the Administration of Justice; those should be finalized by that time.

8 *Public Comment

Dr. Yacenda once again identified himself for the record. He stated he is a Commissioner on the State's Juvenile Justice Commission, and he is also the college campus chair for the Dean of the College of Health and Human Services.

9 *Adjournment

Brett Kandt made a motion to adjourn. Andrea Sundberg seconded the motion. The meeting was adjourned at 10:33 a.m.
