## Instructions for filling out the Tobacco Tribal Retailer Monthly Reporting Form

On the first page of this Form indicate which tribe bought the Non-Participating Manufacturer (NPM) cigarettes or Roll-Your-Own (RYO) product.

Fill in the store's physical address and the month and year for which you are reporting. Please note that **each individual store** needs to fill out a Form for each month that NPM tobacco products are sold.

In the first Table under "Received From" please report which distributor you bought the product from.

Report how many packs were **sold** during the month noted on the first page.

In the RYO table, please report which distributor you bought the NPM tobacco product from and whether the package was 6 ounces, 12 ounces, or 16 ounces. Then report how many total packages of each RYO that you sold during the month noted on the first page.

Please note that the Attorney General's Office will use a standard conversion formula to convert ounces of RYO into cigarettes. Under Nevada Revised Statutes 370A.050, 0.09 ounces of "roll-your-own" tobacco constitutes one individual cigarette.

Before submitting the form, have a representative of the Tribe sign the last page of this document. Finalized forms can be submitted by mail or to [tobaccoenforcement@ag.nv.gov](mailto:tobaccoenforcement@ag.nv.gov).

The Attorney General's Office will verify all reported numbers at the end of each quarter. Our Office will correspond with each tribe to confirm the numbers reported.
