**APPROVED TRAINING INFORMATION**

**Important Information Regarding Training**

- The Committee allows up to ½ of yearly continuing education credits and up to ½ of formal training (equally split between victim and perpetrator hours) to be obtained via distance media
- Beginning January 1<sup>st</sup>, 2010, all courses will expire two years from the date of approval. Courses that expire can be resubmitted and re-evaluated. Courses will be valid toward formal training hours as long as the course was taken during the time that it was valid.
  - Credit will not be given for continuing education if you have taken the same course immediately preceding 2 years.
