Agenda item #3: Moved to approve the minutes from the October 26, 2015 meeting minutes. Committee members approved the meeting minutes.

Agenda item #4: Judge Voy spoke about a study he is conducting regarding recidivism and juvenile sex offenders; conducting study with 26 variables. There is a 5 – 8% recidivism rate. Very rare to come across a juvenile that has deviant sexual tendencies. Waiting for final statistics, working with NCIC. Hoping study will clarify recidivism question regarding juveniles. There are 24 cases of juveniles (high end) where there are no cases of reoffending. Working with Dr. Pallini on study. Will not need any further statutory assistance to complete study. Any recidivism cases are crimes of opportunity. Assemblyman O'Neill offered up a research organization search.org. Judge Voy asked to consider a way to separate juveniles.

Agenda item #5: Chief Deputy Attorney General Brett Kandt provided an overview of SB99 (presentation available). Susan Roske asked about SMART Office and compliance. Brett responded that he would have to defer to subject experts in the office regarding compliance. Mr. Schick asked about SB99. Brett stated that it was a vehicle to get juveniles addressed.
