  - a. Members discussed what data points they want to get from criminal justice system, where those data points may come from and how to partner the entire system up in reporting the additional data identified.
  - b. Data points: DV Homicides (once it's a homicide it is charged as a murder statute and loses the DV designation, so we are unsure of exactly how many DV homicides are occurring each year in Nevada.
  - c. Murder/Suicides also loose the DV designation.
  - d. Seems prosecution could solve both for tracking. Maybe we could have it all tracked in NIBRS.
  - e. Also want to track the number of cases submitted to prosecution by law enforcement vs. number of cases charged.
  - d. Northern Nevada Regional Intelligence Center has been very helpful for gathering criminal justice statistics. Try and find one in Clark County.
  - f. Work off of prosecution monitoring bill ACR 6 for data points on prosecution side.
  - g. Main goal is to have a statewide consistent policy, consistent plan, and consistent source of data.
  - h. From the courts we need TPO denials so we can show the whole ecosystem of the TPO denial along with the Dale (Fatality Risk Tool) along with child abuse and all this around one abuser. At this point we start to see where we're letting survivors down.
  - i. Nevada Department of Sentencing Policy and the Director, Georgia Powers, may have some statistics that are useful to this subcommittee.
  - j. From a quantitative analysis perspective, SafeNest has got enough data to be viable for Clark which could be translated to Washoe with a 95% confidence interval.
  - k. Motion approved unanimously for Nicole Reilly to put together a draft action plan from this meetings discussion to review at the next meeting.
