COUNT ONE

**PERFORMANCE OF ACT IN RECKLESS DISREGARD OF PERSONS OR PROPERTY
RESULTING IN DEATH**

(Category "C" Felony – NRS 202.595(2))

Defendant, RAYNALDO J. RAMOS did, on or about November 12, 2014, then and there willfully and unlawfully perform acts in willful or wanton disregard of the safety of persons or property resulting in the death of CARLOS PEREZ, a human being, in the following manner, to wit: by shooting at and into the chest, neck and head of CARLOS PEREZ with a firearm, which act proximately caused the death of CARLOS PEREZ.

COUNT TWO

INVOLUNTARY MANSLAUGHTER

(Category "D" Felony – NRS 200.070 and 200.090)


Defendant, RAYNALDO J. RAMOS did, on or about November 12, 2014, unlawfully and feloniously kill CARLOS PEREZ, a human being, without any intent to do so, in the commission of an unlawful act, to-wit: a battery, which act proximately caused the death of CARLOS PEREZ, by shooting at and into the chest, neck and head of CARLOS PEREZ with a firearm.

All of which is contrary to the form, force and effect of statutes in such cases made and provided against the peace and dignity of the State of Nevada. Said Complainants make this declaration subject to the penalty of perjury.
