17 **INFORMATION**

18 The undersigned, CATHERINE CORTEZ MASTO, Attorney General of the State of
19 Nevada, by and through Deputy Attorney General, KAREN A. WHELAN, informs this Honorable
20 Court that the above named Defendant, **EUGENIO DIMAS**, has committed the following crime
21 within the County of Clark, State of Nevada, as follows:

22 **COUNT ONE**

23 **MISCONDUCT OF PUBLIC OFFICER**

24 **(Category "E" Felony – NRS 197.110)**

25 That the defendant, EUGENIO DIMAS, did unlawfully and feloniously, as a public officer,
26 ask or receive, directly or indirectly, any compensation, gratuity or reward, or promise thereof, for
27 omitting or deferring the performance of any official duty, or, employ or use any person, money, or
28 property under the public officer's official control or discretion, or in the public officer's official

1 custody, for the private benefit or gain of the public officer or another, to wit: That on or about
2 September 25, 2012 through October 14, 2012, Department of Corrections Employee EUGENIO
3 DIMAS asked or received compensation in exchange for omitting to perform his official duties at
4 Florence McClure Woman's Correctional Center and/or did use his uniform, identification, or other
5 property under his official control for his private benefit to-wit: by using his position as a corrections
6 officer employed by the State of Nevada to coerce inmate Monique Maestas to engage in
7 prohibited sexual activities with him while she was under his management in the prison in
8 exchange for money or other private benefits. All of which constitutes the crime of **MISCONDUCT**
9 **OF PUBLIC OFFICER**, a Category "E" Felony in violation of NRS 197.110.

10 All of which is contrary to the form, force and effect of statutes in such cases made and
11 provided against the peace and dignity of the State of Nevada.
