DEFENDANT MEGAN MARIE KLEIN, on or between the dates of June 20, 2013. and January 16, 2014, within Carson City, Nevada, did knowingly, willfully and unlawfully obtain and use the personal identifying information of another person with the intent to commit an unlawful act. More specifically, DEFENDANT MEGAN MARIE

KLEIN obtained and used Ashleigh Fisicaro's name for the purpose of defrauding David Meltzer and Russell Berman by using misrepresentations, and signing Ashleigh Fisicaro's name in an attempt to sell fake minority portions of a professional sports team and/or 2014 season floor seats.

All of which is contrary to the form, force and effect of the statutes in such cases, made and provided, and against the peace and dignity of the State of Nevada.
