24 **COUNT I – MORTGAGE FRAUD**

25 **A Category B felony in Violation of NRS 205.372(2)**

27 County of Washoe, State of Nevada, did violate NRS 205.372 by engaging in a pattern of
28 mortgage lending fraud by knowingly making false statements or misrepresentations
