22 **COUNT ONE**
INSURANCE FRAUD

23 **(A Category D Felony in violation of NRS 686A.2815 and NRS 686A.291)**

24 On or about November 19, 2013, and December 12, 2013, in Clark County, Nevada,
25 Defendant KRYSTAL DYCE knowingly and willfully presented or assisted, abetted, solicited,
26 or conspired with another person to present, or caused to be presented, to an insurer false or
27 misleading information concerning a material fact in support of a claim for benefits made
28 under a policy of insurance issued pursuant to the Nevada Insurance Code, to wit: DYCE

1 participated in the burning of her home, located at 6137 Sterling Cap Street, North Las Vegas,
2 NV 89081, and then gave false statements to Traveler's Insurance Company in support of a
3 claim for benefits for damages caused by the fire.

4 All of which is contrary to the form, force, and effect of the statutes in such cases made
5 and provided and against the peace and dignity of the state of Nevada. Plaintiff, THE STATE
6 OF NEVADA, by and through its undersigned counsel, makes these statements upon
7 information and belief.
