18 Plaintiff, THE STATE OF NEVADA, by and through its counsel, ADAM PAUL LAXALT,  
19 Attorney General, and ROGER R. MADSEN, Senior Deputy Attorney General, hereby informs  
20 this Court that Defendant, MICHAEL JOSEPH BRICKER, did, in the county of Clark, state of  
21 Nevada, commit the following offense(s):

**COUNT ONE:**  
**FALSE STATEMENTS OR REPRESENTATIONS/  
23 CONCEALMENT OF MATERIAL FACT TO OBTAIN BENEFITS**  
**(NRS 616D.300/616D.620 – Category D Felony)**

25 On or about March 18, 2013 through May 1, 2014, Defendant, MICHAEL JOSEPH  
26 BRICKER, unlawfully, knowingly and feloniously made one or more false statements or  
27 representations, or concealed one or more material facts, to his employer (First Cup Partners  
28 Las Vegas LLC dba Dunkin' Donuts), the workers' compensation insurer for his employer (The

1 Hartford) and/or his health care providers in order to obtain or attempt to obtain workers'  
2 compensation benefits or payments, including one or more controlled substances, under the

4 Act. During said time period and for said purposes, Defendant did in fact obtain benefits or  
5 payments, including one or more controlled substances, in the amount of \$250 or more under  
6 workers' compensation claim number YZS52112C, *to wit: A did not disclose*  
7 *prior injury.* *Ⓚ*  
8 All of which is contrary to the form, force and effect of the statutes in such cases made  
9 and provided, and against the peace and dignity of the state of Nevada.
