## AMENDED CRIMINAL INFORMATION

The STATE OF NEVADA by and through CATHERINE CORTEZ MASTO, Attorney General, and her deputy ROBERT G. GIUNTA, hereby informs the Court and states that the Defendant, PETER DOUGLAS ORTMANN (hereinafter "ORTMANN"), a.k.a. TAHITI PETEY, has committed: SALE OF UNREGISTERED SECURITIES, a category B felony in violation of NRS 90.460 and NRS 90.650(1)(a), one (1) Count; that the aforementioned offenses occurred from May, 2006, through August, 2006, within the County of Clark, State of Nevada in the following manner:

#### COUNTI

## SALE OF UNREGISTERED SECURITIES NRS 90.460 and NRS 90.650(1)(a)— a class B felony

That on or about May 17, 2006, the Defendant ORTMANN did knowingly and willingly, within the County of Clark, in the State of Nevada, sell a security in the State of Nevada which was not registered under Chapter 90 of the Nevada Revised Statutes, to wit, did sell shares of

stock in ""Starfish Capital Partners, Inc., to Robert P. Negra despite the fact that Starfish Capital Partners, Inc. was not a security registered by the State of Nevada pursuant to NRS 90.310 and has not filed an exemption for said securities. These actions by Defendant ORTMANN constitutes the crime of SALE OF UNREGISTERED SECURITIES, a felony in violation of NRS 90.460 and NRS 90.650(1)(a).
