18 Plaintiff, THE STATE OF NEVADA, by and through its counsel, ADAM PAUL LAXALT,
19 Attorney General, and ROGER R. MADSEN, Senior Deputy Attorney General, hereby informs
20 the court that Defendant, JESSE MICHAEL WHITLOCK, did, in the county of Clark, state of
21 Nevada, commit the following criminal offense:

22 **COUNT ONE**
23 **THEFT**
(NRS 205.0821 to NRS 205.0835, inclusive; NRS 195.020 - Category B Felony)

24 On or between December 27, 2010 and August 16, 2011, Defendant, JESSE
25 MICHAEL WHITLOCK, did unlawfully and knowingly obtain unemployment insurance benefits,
26 valued at \$2,500 or more, from the Nevada Department of Employment, Training and
27 Rehabilitation, Employment Security Division by one or more material misrepresentations with
28 intent to deprive that state agency of said personal property; and/or did aid or abet another in

1 doing so, whether present or absent; and/or did directly or indirectly counsel, encourage, hire,
2 command, induce or otherwise procure another in doing so. Defendant did so by causing or
3 allowing unemployment insurance claims to be filed on his behalf during his incarceration and
4 by misrepresenting his employment status to said state agency.

5 All of which is contrary to the form, force and effect of the statutes in such cases made
6 and provided, and against the peace and dignity of the state of Nevada.
