19 ADAM PAUL LAXALT, Attorney General for the state of Nevada, in the name and by the
20 authority of the state of Nevada, informs the Court:

21 Defendant, NANCY RAMIREZ MONTELONGO, has committed the crime of: one (1)
22 count of INSURANCE FRAUD, a category D felony, in violation of NRS 686A.281 to NRS
23 686A.295, inclusive.

24 All of the acts alleged herein have been committed or completed on or between about
25 October 21, 2013, and November 7, 2013, by the above-named defendant, within the county of
26 Clark, state of Nevada, in the following manner:

COUNT I
INSURANCE FRAUD
(Category D Felony – NRS 686A.281 to NRS 686A.295, inclusive)

Defendant, NANCY RAMIREZ MONTELONGO, did without lawful authority: knowingly and willfully present or cause to be presented any statement as a part of, or in support of, a claim for payment or other benefits under a policy of insurance, knowing that the statement conceals or omits facts, or contains false or misleading information concerning any fact material to that claim; and/or act or fail to act with the intent of defrauding or deceiving an insurer, a reinsurer, a producer, a broker or any agent thereof, to obtain any proceeds or other benefits under a policy of insurance; and/or participate in, assist, aid, abet, solicit or conspire with another person to present or cause to be presented any statement to an insurer, a reinsurer, a producer, a broker or any agent thereof, knowing that the statement conceals or omits facts, or contains false or misleading information concerning any fact material to a claim for payment or other benefits under a policy of insurance, or any of the foregoing acts or omissions, to wit:

Defendant, NANCY RAMIREZ MONTELONGO, did commit said crime by initiating a claim under an insurance policy (State Farm Policy Number 042 1547-C17-28C/Policy Period: September 17, 2013, to March 17, 2014/State Farm Claim Number 28-25Q0-926) in which she fraudulently represented that her motor vehicle (2006 Chrysler 300/Vehicle Identification Number: 2C3KA43R76H459056) had been stolen, on October 20 or October 21, 2013, while parked in front of her brother's residence in Las Vegas, Nevada; when in truth and in fact, she knew her motor vehicle had been parked in Stockton, California, since approximately October 15, 2013, in a damaged condition. As a result of Defendant's wrongful conduct, proceeds or other benefits were paid.

All of which constitutes the crime of INSURANCE FRAUD, a category D felony, in violation of NRS 686A.281 to NRS 686A.295, inclusive.
