3 for the purpose of providing for her care, and subsequently converted and/or used  
4 approximately \$6,183.48 from the estate and/or person of HELEN MAE FORDIN for his  
5 personal expenses, with the intention of permanently depriving HELEN MAE FORDIN of  
6 the ownership, use, benefit or possession of said money, assets or property.

7 COUNT II

8 THEFT

9 a Category B felony in violation of NRS 205.0832(1)(b) & NRS 205.0835(4)

10 That the said defendant, WADE E. FORDIN, within Elko Township, County of Elko,  
11 State of Nevada, on or between February 26, 2012, and November 6, 2013, did  
12 unlawfully, knowingly, and without lawful authority, convert or use the property of HELEN  
13 MAE FORDIN, while said property was entrusted or placed in his possession for a limited  
14 use, said property valued in excess of \$3,500.00, in the following manner:

15 WADE E. FORDIN was entrusted with money as the guardian of the estate and/or  
16 person of HELEN MAE FORDIN, for the limited purpose of providing for her care, and  
17 subsequently converted and/or used approximately \$6,183.48 of said money for his  
18 personal expenses.

19 All of which is contrary to the form, force and effect of the statutes in such cases  
20 made and provided, and against the peace and dignity of the State of Nevada.

21 WHEREFORE, the undersigned complainant requests that a Warrant be issued  
22 so that defendant may be hailed into Court and answer to the charges according to law.
