**INFORMATION**

The State of Nevada, by and through legal counsel, ADAM PAUL LAXALT, Attorney General, and MARK J. KRUEGER, Senior Deputy Attorney General, in the name and authority of the State of Nevada, informs the court that CHARLENE ANNE SCREETON-PETRI, the Defendant, above-named, in Carson Township, Carson City, State of Nevada, has committed the crime of **ATTEMPT TO SUBMITTING FALSE CLAIMS: MEDICAID FRAUD**, a category E felony or Gross Misdemeanor in violation of NRS 422.540(1), NRS 422.540(2)(a) and NRS 193.330(1)(a)(5) (Count I); in the manner following:

Count I

**ATTEMPT TO SUBMITTING FALSE CLAIMS: MEDICAID FRAUD**

**("E" Felony or Gross Misdemeanor – NRS 422.540(1), NRS 422.540(2)(a) and NRS 193.330(1)(a)(5))**

1 That the Defendant, CHARLENE ANNE SCREETON-PETRI, on or between  
2 September 1, 2014 and February 28, 2015, did attempt to commit, with the intent to defraud,  
3 an offense with respect to the State Plan for Medicaid, by making a claim or caused a claim to  
4 be made, knowing the claim to be false, in whole or in part, by commission or omission, and/or  
5 making or causing to be made a statement or representation for use by another in obtaining  
6 goods or services pursuant to the State Plan for Medicaid, knowing the statement or  
7 representation to be false, in whole or in part, by commission or omission, all of which  
8 occurred in the manner following, to wit: Defendant attempted to use information, including  
9 information of Medicaid recipients and/or their Medicaid recipient identification numbers, of  
10 L.S. (Medicaid ID No. XXXXXX48832) and/or M.L. (Medicaid ID No. XXXXXX58063) and  
11 attempted to submit or caused to be submitted, claims to the State Plan for Medicaid for  
12 reimbursement while representing she had provided certain Medicaid approved services to  
13 the Medicaid recipients which were not provided by Defendant, and the amount of the claims  
14 or value of the goods or services obtained or sought to be obtained was greater than \$650.00.

15 All of which is contrary to the form, force and effect of the Statutes in such cases made  
16 and provided and against the peace and dignity of the State of Nevada.

17 Pursuant to NRS 239B.030, the undersigned hereby affirms that this document does  
18 not contain personal information about any person.
