19	The above named Defendant, EMMANUAL FORD, is accused by the Clark County Grand Jury	
20	of the crime of COUNT 1 - MULTIPLE TRANSACTIONS INVOVLING FRAUD OR DECEIT,	
21	(CATEGORY "B" Felony), in violation of NRS 205.377 and COUNT 2 - THEFT, (CATEGORY	
22	"B" Felony), in violation of NRS 205.0832(1)(c), in C	Clark County, State of Nevada as follows:
23	<u>COUNT I</u>	
24	MULTIPLE TRANSACTIONS INV	OVLING FRAUD OR DECEIT
25	Category "B" Felony – NRS 205.377	
26	That on or between April 24, 2013 and March 20, 2014, the Defendant, EMMANUAL FORD,	
27	within the County of Clark, State of Nevada, in the course of an enterprise or occupation, knowingly and	
28	with the intent to defraud, engaged in an act, practice of	or course of business or employed a device, scheme

or artifice which operated or would have operated as a fraud or deceit upon a person by means of false representation or omission of a material fact that: (a) the person knew to be false or omitted; (b) the person intended another to rely on; and (c) resulting in a loss to any person who relied on the false representation or omission, in at least two transactions that had the same or similar patter, intents, results, accomplices, victims or methods of commission, or were otherwise interrelated by distinguishing characteristics and we not isolated incidents within 4 years and in which the aggregate loss or intended loss was more than \$650, to wit:

In the course of his occupation as a telemarketer, the Defendant, knowingly and with the intent to defraud, engaged in a tele-marketing business, which operated as a fraud upon numerous individuals including, but not limited to Gail Green, Mickey Sergeant, Catherine Mulholland and Joe Stoller, by means of falsely informing said individuals that they could profit from investing in the Defendant's business, knowing that said individuals would not profit from said investment, and intending that said individuals rely on said misrepresentation, and resulting in a loss of more than \$650.00.

COUNT 2

THEFT

Category "B" Felony - NRS 205.0832(1)(c) and NRS 205.0835

That on or between April 24, 2013 and March 20, 2014, the Defendant, EMMANUAL FORD, within the County of Clark, State of Nevada, either by virtue of his own actions or by the actions of his agents and employees, did knowingly and without lawful authority, obtain the property or services of another person by a material misrepresentation with the intent to deprive the person of the property or services, and the value of said property was \$3,500.00 or more, to wit: the Defendant received money from Gail Green, and/or Mickey Sergeant, and/or Catherine Mulholland, and/or Joe Stoller by falsely representing to said individuals that the money paid to the Defendant would be an investment in a webbased business that would result in said individuals receiving profits based on customer activity on a particular website, and said actions were taken with the intent to permanently deprive said individuals of the money they invested; with said investments having a value of \$3,500.00 or more.

1	All of which is contrary to the force and effect of the Nevada Revised Statutes in such cases and
2	against the peace and dignity of the State of Nevada.
