COUNT I
FALSE STATEMENT TO OBTAIN UNEMPLOYMENT BENEFITS IN EXCESS OF \$650
(Category C Felony - NRS 612.445(5) and NRS 205.0835)

That the said defendant, MITZIE ROCHELLE HENDRIX, within Las Vegas Township, Clark County, State of Nevada, did unlawfully make false statements and/or representations, knowing them to be false, to obtain benefits or other payments for herself and/or Joel Hendrix under the Unemployment Compensation Act, in an amount in excess of \$650.00, in the following manner:

That on or between February 21, 2017, and May 16, 2017, the defendant filed false wage reports and/or a false application for benefits with respect to Joel Hendrix's employment with Elite Intergrity (sic) Property Management with the Nevada Employment Security Division, and subsequently received payments of approximately \$2,982.00 in unemployment compensation benefits for herself and/or Joel Hendrix.

All of which constitutes the crime of MAKING FALSE STATEMENTS AND/OR REPRESENTATIONS TO OBTAIN UNEMPLOYMENT COMPENSATION BENEFITS IN VIOLATION OF NRS 612.445.


All of which is contrary to the form, force and effect of the statutes in such cases made and provided, and against the peace and dignity of the state of Nevada.
