That the said defendant, VICKY JO ADAMS aka VICKY JO LINDBLADE, within Carson City, State of Nevada, did knowingly and unlawfully exploit an older person or a

vulnerable person or any use of the power of attorney or guardianship of an older person or a vulnerable person over 60 years of age, by converting money, assets and/or property with a value of over \$5,000, with the intention of permanently depriving the older person of the ownership, use, benefit or possession of his money, assets or property, by way of acts that involved, directly or indirectly, any component, device, equipment, system or network that, alone or in conjunction with any other component, device, equipment, system or network, is designed or has the capability to (a) be programmed; or (b) generate, process, store, retrieve, convey, emit, transmit, receive, relay, record or reproduce any data, information, image, program, signal or sound in a technological format, including, without limitation, a format that involves analog, digital, electronic, electromagnetic, magnetic or optical technology, to wit: the Defendant, VICKY JO ADAMS aka VICKY JO LINDBLADE, converted and/or used over \$5,000 obtained from an ATM machine using a Wells Fargo bank debit card belonging to John Lindblade (DOB 7/12/1924), for her personal use and not for the intended purpose of providing for the care of John Lindblade, with the intention of permanently depriving John Lindblade of the ownership, use, benefit or possession of said money, assets or property.
