19 ADAM PAUL LAXALT, Attorney General for the state of Nevada, in the name and by the
20 authority of the state of Nevada, informs the Court:

21 Defendant, SOJOURNER T. DANYAL MARABLE, has committed the crime of: One (1)
22 Count of INSURANCE FRAUD, a category D felony in violation of NRS 686A.281 to NRS 686A.295,
23 inclusive.

24 All of the acts alleged herein were committed on or between about November 22, 2015 and
25 December 8, 2015, by the above-named defendant, within the county of Clark, state of Nevada, in the
26 following manner:

1 **COUNT I**
2 **INSURANCE FRAUD**
3 **(Category D Felony - NRS 686A.281 to NRS 686A.295, inclusive)**

4 Defendant, SOJOURNER T. DANYAL MARABLE, did without lawful authority, knowingly
5 and willfully present or cause to be presented any statement as a part of, or in support of, a claim for
6 payment or other benefits under a policy of insurance, knowing that the statement conceals or omits
7 facts, or contains false or misleading information concerning any fact material to that claim; and/or act
8 or fail to act with the intent of defrauding or deceiving an insurer, a reinsurer, a producer, a broker or
9 any agent thereof, to obtain any proceeds or other benefits under a policy of insurance; and/or accept
10 any proceeds or other benefits under a policy of insurance knowing that the proceeds or other benefits
11 are derived from any of the foregoing acts or omissions; and/or participate in, assist, aid, abet, solicit or
12 conspire with another person to present or cause to be presented any statement to an insurer, a reinsurer,
13 a producer, a broker or any agent thereof, knowing that the statement conceals or omits facts, or
14 contains false or misleading information concerning any fact material to a claim for payment or other
15 benefits under a policy of insurance, or any of the foregoing acts or omissions, to wit:

16 The above-named defendant presented a false insurance claim to State Farm Mutual
17 Automobile Insurance Company, under claim number 28-7N66-944, claiming that on November 21,
18 2015, she was hit by a motor vehicle driven by the insured, Tameka Nicole Green, when in truth and in
19 fact, the accident never occurred. As a result, \$7,500 was accepted from State Farm Mutual Automobile
20 Insurance Company.

21 All of which is contrary to the form, force and effect of the statutes in such cases made and
22 provided, and against the peace and dignity of the state of Nevada.
