17 AARON D. FORD, Attorney General of the State of Nevada, and ALISSA C. ENGLER, Senior
18 Deputy Attorney General, in the name and by the authority of the State of Nevada, inform the above-entitled
19 court that STORMY ROBERTSON contrary to the form, force and effect of statutes in such cases made
20 and provided, and against the peace and dignity of the State of Nevada, committed the following offense:

21 **COUNT I**
22 **CHILD ABUSE NEGLECT OR ENDANGERMENT**
23 **Category "B" Felony - NRS 200.508**

24 That the defendant, STORMY ROBERTSON, on or between June 23, 2019, and July 24, 2019, did
25 willfully, unlawfully and feloniously cause A.S., a child who was less than 18 years of age, to suffer
26 unjustifiable physical pain or mental suffering as a result of abuse or neglect, to wit: sexual exploitation,
27 and/or cause A.S. to be placed in a situation where he or she may have suffered physical pain or mental
28 suffering as a result of the abuse or neglect, to wit: sexual exploitation, by forcing, allowing, and/or
encouraging A.S. to solicit for or engage in prostitution.
