# Overview of Substance Use Services



BBHWP manages various funding sources for substance use prevention, treatment and recovery services.

## State General Funds

 This presentation focuses on the general fund accounts that directly support the Substance Use Prevention Treatment and Recovery Services (SUPTRS) Block Grant through way of "maintenance of effort"

# **Prevention**



- Substance use prevention is a proactive process that empowers individuals and communities to prevent the initiation of substance use and reduce associated risks.
- Goal: promote health behaviors, strengthen protective factors, reduce risk factors before problems occur.
- SAMHSA Prevention Framework:
  - Data-driven
  - Evidence-based
  - Community-Centered
  - Culturally responsive
- Evidence-Based Guiding Model: <u>Strategic Prevention Framework (SPF)</u>





### **Primary Prevention:**

Goal: Prevent substance use before it starts

Focus: Reduce risk factors and strengthen protective factors

Examples: School-based prevention education

Parent skill-building programs

Media campaigns promoting healthy choices

For the sake of tracking within all programs, primary prevention is the only type of prevention explicitly tracked as most programs have secondary and tertiary sprinkled throughout.





#### **Secondary Prevention:**

Goal: Early identification and intervention for those at risk or showing early signs of use

Focus: Stop progression to misuse or dependence

Examples: Screening, Brief Intervention, and Referral to Treatment (SBIRT)

Early intervention for youth experimenting with substances

#### **Tertiary Prevention:**


Goal: Reduce the impact of established substance use disorders and prevent relapse

Focus: Treatment, recovery support, and harm reduction

Examples: Recovery housing and peer support

Medications for Opioid Use Disorder


Relapse prevention programs



# State General Funds (Maintenance of Effort)



- SubUnit 11 is funding substance use prevention initiatives in our community:
  - Grant a Gift Autism Foundation Ackerman Center providing prevention services to at-risk youth that are diagnosed with FASD
  - Nevada Cancer Coalition providing education and resources to retailers in Nevada to prevent underage purchasing of tobacco and tobacco products
  - PACE Coalition substance use primary prevention activities in Elko County
- SubUnit 16 revenue is generated from certification fees and funds a portion of the BHCEN certifications for substance use prevention and treatment agencies (NAC458.103).
  - Portion of funds applied to the certification activities for prevention coalitions and prevention programs.



# Federal Funds – SUPTRS BG



- The SUPTRS Block Grant is one of the main grants the Bureau manages for substance use initiatives.
- Two-year performance cycle, with yearly budgetary allocations.
- New "full cycle" begins October 1, 2025.
- Required 20% set-aside from the full grant amount for primary prevention activities (including state-level costs/projects/supports, and dollars disseminated throughout the community to certified prevention coalitions or certified prevention programs)

# Federal Funds – SUPTRS BG



- Plan, implement and evaluate activities for the prevention, treatment of substance use disorders, and to provide recovery support services. Funding priority for uninsured.
- Funding certified primary prevention coalitions and certified prevention programs
  - Topic Areas for Primary Prevention:
    - School-based programming for substance use prevention
    - Drug take-back programs
    - Education and awareness related to substance use topics
    - Family/community engagement activities
    - Student-led peer groups/activities





  - Healthy Communities Coalition
  - Churchill Communities Coalition
- Topic Areas:
  - Middle School & High School Suicide-Related Behaviors
  - Middle School & High School Vaping
  - Middle School & High School Prescription Pain Medicine Use
  - Middle School & High School violent and depressive behaviors
  - Capacity Building



# Funds for Primary Prevention Only



- Substance Use Prevention Treatment and Recovery Services (SUPTRS)
   Block Grant & Related General Funds
  - \$8,435,646
- 2. Partnership for Success (PFS) Grant
  - \$1,250,000
- 3. State Opioid Response (SOR) Grant
  - \$1,341,761

Current annual dollar amounts for specific primary prevention activities and supports.

Elevation and refinement of recommendation included in the 2024 Annual Report

Recommend to DHHS/DPBH/the Bureau of Behavioral Health Wellness and Prevention to include in their Governor's budget request, a request double the amount of investment in SAPTA primary prevention programming (i.e., For example, if the current level of investment was \$12 million, then this would be raised to \$24 million for the next biennium increase from current \$12 million to \$24 million for this biennium) for ages 0-24 and review the funding allocations annually. This funding should not be at the expense of existing programming. Additionally, this funding should be the State of Nevada's contribution to Prevention efforts; additional Federal and/or other monies that are secured would not change the target allocation of State dollars for primary prevention efforts. Monies should be directed to local lead agencies.

New recommendation

Request guidance from the Nevada Board of Pharmacy posted to their website and communicated to pharmacists to clarify regulations pertinent to the distribution of naloxone in hospitals to permit low barrier naloxone distribution from Emergency Departments (EDs) and Permit EDs to adopt a naloxone-specific standard operating procedure (SOP) for public naloxone distribution, separate from and exempt from the regulatory framework surrounding hospital formulary medications used in patient care.

Elevation of recommendation included in the 2024 Annual Report:

Create a bill draft request to allocate a 15 percent set aside of cannabis retail funds to be distributed using a local lead agencies model to reach \$2 per capita, a recommended funding goal from the Nevada Tobacco Control & Smoke-free Coalition and subject matter experts.
