History of CCBHCs in Nevada

- The Certified Community Behavioral Health Center Program began as a Substance Abuse and Mental Health Services Administration (SAMHSA) Demonstration Project. The first year was the planning stage and states that successfully demonstrated the ability to implement the next phase of the program were selected.
- There were initially 24 states that were awarded the planning grant for the Demonstration Program. Out of those 24 states, Nevada was chosen as 1 of 8 states that were awarded to move forward with the 2-year implementation phase of the project.



History Continued

The Certified Community Behavioral Health Center (CCBHC) model alleviates decades-old challenges that have led to a crisis in providing access to mental health and addiction care.

As an integrated and sustainably-financed model for care delivery, CCBHCs:

- Ensure access to integrated, evidence-based addiction and mental health services.
- Meet stringent criteria regarding timeliness of access, quality reporting, staffing and coordination with social services, criminal justice and education systems.
- Receive funding to support the real costs of expanding services to fully meet the need for care in their communities.



Where we are now

- State Plan Amendment (SPA) was submitted to Centers for Medicare and Medicaid Management (CMS) January 2023 with approval May 2024
- During the 82nd Legislative Session the Division of Health Care Financing and Policy (DHCFP) received budget authority to add additional CCBHCs Statewide
- July 1, 2023, Nevada is no longer a participant of the Demonstration
- Spa was approved with an effective date of 5-2023

Who can be a CCBHC?

Section 223 of the Protecting Access to Medicare Act (PAMA) (PL 113-93) requires that a CCBHC be one of the following entities:

- A nonprofit organization
- Part of a local government behavioral health authority
- •An entity operated under authority of the IHS, an Indian tribe, or tribal organization pursuant to a contract, grant, cooperative agreement, or compact with the IHS pursuant to the Indian Self-Determination Act.

Benefits of Being a CCBHC

- There is no Prior Authorization required & which lessens the administrative burden on providers
- Providers are paid on a Perspective Payment System (PPS) daily rate
- Quality Incentive payments annually; up to 15% of the providers total payments annually
- Substance Use Disorder (SUD) and Mental Health treatment services
- Evidence based practice with evidence-based tools
- SAPTA certified, substance use treatment
- Targeted Case Management (TCM)
- Patient and Family Centered Care



Summary of CCBHC Services

CCBHCs are responsible for providing all nine Core services, which can be provided directly or through formal relationships with Designated Collaborating Organization (DCOs):

- 1. Crisis Services (including 24-hour mobile crisis response)
- 2. Treatment Planning
- 3. Screening, Assessment, Diagnosis & Risk Assessment
- 4. Outpatient Mental Health & Substance Use Services
- 5. Targeted Case Management
- 6. Outpatient Primary Care Screening and Monitoring
- 7. Community-Based Mental Health Care for Veterans
- 8. Peer, Family Support & Counselor Services
- 9. Psychiatric Rehabilitation Services

Plus, Assertive Community Treatment

Medicaid Billing Overview

- Reimbursement is based on a Prospective Payment System (PPS) methodology. This is similar to an encounter rate or a daily rate.
- Services are billed utilizing an encounter code and all rendered services are billed with a modifier to capture all provided services.
- CCBHCs in the Rural areas are billing through Medicaid Fee for Service
- CCBHCs in Washoe and Clark County are mostly billing through the MCOs
- The providers are also required to shadow bill. With this process Nevada Medicaid can track over time the cost saving.
- New CCBHCs will start with a PPS or daily rate of the statewide average currently about \$220



SAMHSA CCBHC Standard requirements for Medication Assisted Treatment (MAT)

1.b.2. CCBHC staff must include a medically trained behavioral health care provider, either employed or available through formal arrangement, who can prescribe and manage medications independently under state law, including buprenorphine and other FDA- approved medications used to treat opioid, alcohol, and tobacco use disorders. This would not include methadone, unless the CCBHC is also an Opioid Treatment Program (OTP).

If the CCBHC does not have the ability to prescribe methadone for the treatment of opioid use disorder directly, it shall refer to an OTP (if any exist in the CCBHC service area) and provide care coordination to ensure access to methadone.



Quick Summary of FDA Approved Medications for OUD:

Methadone (Full Agonist)

Buprenorphine (Subutex) & Buprenorphine Naloxone (Suboxone) (Partial Agonist)

Naltrexone (Vivitrol & Revia) (Antagonist)

A note on Naloxone (Utilized as overdose reversal medication for opiods)

- The CCBHC Team includes:
 - Nevada Division of Health Care Financing and Policy (DHCFP),
 - Nevada Division of Public and Behavioral Health (DPBH),
 - Health Care Quality Compliance (HCQC),
 - *HCQC is the regulatory entity which certifies programs as a CCBHC's. Standards were established by SAMHSA, but the team were able to utilize existing certification through the Substance Abuse Prevention and Treatment Agency (SAPTA) to meet some of the standards prior to onsite reviews and application of the SAMHSA established standards.
 - Center for the Application of Substance Abuse Technology (CASAT)
 - CCBHCs are subject to annual on-site reviews.
