## **Attorney General Ford Announces Sentencing of Las Vegas Woman and Behavioral Health Company for Medicaid Fraud**

**Las Vegas, NV** – Today, Nevada Attorney General Aaron D. Ford announced that Rodneshia Carter, of Las Vegas, and her company, Love & Loyalty LLC, were sentenced for Medicaid Fraud.

The Honorable Judge Trujillo adjudicated Carter guilty of Attempted Submitting False Claims: Medicaid Fraud, which is a Category E felony. As part of her sentence, Carter was ordered to serve 12-30 months incarcerated (suspended). Additionally, Love & Loyalty was convicted of Submitting False Claims: Medicaid Fraud, which is a Category D felony. As part of the convictions, \$150,000 in restitution was ordered.

The investigation of this case began after the Medicaid Fraud Control Unit (MFCU) received allegations of possible fraud being done at Love & Loyalty. The investigation showed that Carter, through Love & Loyalty, submitted claims to Medicaid for payment for behavioral health services that were never actually provided to Medicaid recipients. The individual servicing providers listed on Medicaid claims denied providing services for Love & Loyalty and Carter knew these services were not actually provided.

The MFCU investigates and prosecutes financial fraud by those providing healthcare services or goods to Medicaid patients. The MFCU also investigates and prosecutes instances of elder abuse or neglect. The Nevada MFCU receives 75% of its funding from the U.S. Department of Health and Human Services under a grant award. The remaining 25% is funded by the State of Nevada, MFCU. Anyone wishing to report suspicions regarding any of these concerns may contact the MFCU at 702-486-3420 or 775-684-1100.

This case was investigated by the Attorney General's Medicaid Fraud Control Unit and is being prosecuted by Senior Deputy Attorney General Behnaz Salimian Molina.
