2. Public comment.

Dennis Fitzpatrick spoke. He pointed out that the approved training is out of date. Interns do not know what is available. The certified provider database is out of date. It contains supervisor listings that are no longer applicable. His annual renewal license for New Beginnings Counseling Centers has not been agenized. His other program LRS has been agenized. The new CEU training is not offered in Nevada. He suggested that they accept the old CEU format. He emphasized that the new courses should be given in Nevada. He described that the new CEU courses taken out of state give students an unnecessary financial hardship.

She recommended approval with a note to him that he needs to provide the supervisor observation forms for all groups that don't include him.

There is a concern, the person who signed off as a supervisor has not been approved as a supervisor, but was in fact approved as a provider at the last meeting. He recommends continuance until further information is received from this program.
