1. ***Call to order, roll call of members, and introduction.**
Brett Kandt called the meeting to order at 2:00pm. A roll call was performed and quorum was established.
2. ***Approval of Minutes from August 16, 2007 meeting.**
Traci Dory moved to approve the minutes. Tammy Whatley seconded the motion. The minutes were approved.
3. *** Discussion and possible action on Council brochure – both content and design.**

Kareen Prentice explained that the minutes of the previous meeting noted that it was requested by the Committee that the Statewide Domestic Violence Hotline number be added to the brochure, and that an explanation of domestic violence and the purple ribbon be added as well. Brett Kandt explained that at a subsequent meeting of the Council, it was decided that the purpose of the brochure was not to target victims, but rather the community as a whole, and to inform professionals and the community of what the Council does, not to define the meaning of domestic violence. It was decided that a short narrative on the meaning behind the purple ribbon symbol would be included along with the hotline number. Tammy Whatley made the motion that the changes be made to the brochure as outlined, and Traci Dory seconded the motion.

4. *Update on NCPDV website content.

It was decided by the Committee to update the information available on the current website to include one year of meeting agenda/minutes in pdf format.

5. * Election of new chair.

Tammy Whatley suggested that the Committee wait and see if any new members join the Committee before electing a new chair. Henna Rasul pointed out that since a new chair hasn't been elected yet, Brett Kandt will remain as chair until a new one is elected. Brett will mention the need for new members and a chair on the Committee during his report on committee membership as Secretary at the Council meeting. He requests that staff be ready to supply information on which committees are in need of new members and the requirement of members to actually participate in the committees they join.

6. * Schedule future meetings & agenda items.

The next meeting of the Criminal Justice Committee will be held in the month of August in the Reno office of the Attorney General. The exact date will be decided later.
