2. **Public Comment.**

- a. None.

3. **For Discussion:** Teresa Benitez-Thompson, Nevada Office of the Attorney General Chief of Staff, will discuss the NV S.A.V.E. victim notification system. (Please note, this Agenda item was taken out of order to facilitate external members' time and availability).

- a. The new victim notification system, NV S.A.V.E., went live on August 29th. The state of Nevada was fully impacted by a statewide cyber-attack that did impact the go-live of the NV S.A.V.E. system. We are coming to the three-month mark of implementation and have been slowly navigating the transition from VINE to NV S.A.V.E. through data migration, minor bug fixes, and integrating every county and prison facility into one program. The statewide shutdown impacted our ability

to send or receive email notifications, some jails were fully offline or were protecting their data by voluntarily shutting off their data feeds, and there was a ton of data cleanup and duplications from all uploaded data from the previous system.

- b. Chief of Staff Teresa Benitez-Thompson wanted to stress how thankful everyone is for all the cooperation during such a stressful shutdown and transition (with special consideration going to the Sheriffs and Chiefs, advocates for their help finding and solving errors in the system, and to staff who work within all the different jail management systems).
- c. Due to so many facilities being offline or not sending data, there were discrepancies in the data where some custody statuses were incorrect for offenders in our state. The Office of the Attorney General and Nevada Department of Corrections have been working diligently with Sylogist, the vendor behind the NV S.A.V.E. system, to mitigate these instances and strengthen notifications going out to registrants within the system.
- d. The conversation was opened for any questions, with the first being what the benefit of the NV S.A.V.E. system being outside of the state system is. As shown by the cyber-attack, having a victim notification system on its own server means notifications will still be sent out regardless of if the state servers are down. The chosen offsite server is tied to Microsoft Azure which is safer and less liable for attack. In terms of data security, it also protects offender and registrant information from being sold or used to further traumatize families and survivors. The attack highlighted the need for more discussion around cybersecurity, which is a bill coming up in the Nevada special session of the legislature.
- e. What are we doing to ensure that if there is ever another cyber attack that the victim notifications don't go offline and how we are mitigating offline issues for the system? Nathan Branscome, Senior Director for victims at Sylogist, answered that the environment that runs NV S.A.V.E. is in a Microsoft data center, based in the US, with a GeoACP backup (which is CGIS certified, operating outside the Nevada state direct domain), so that even with another ransomware attack, there are several layers of protection and misdirection to make it that much harder for anyone to access the data within the notification program. The bigger issue, outside of our control, is that if the statewide servers go down, some jails can't feed their data actively into the system, but we have set up a manual override emergency system so that notifications can still manually go out as jails input this information into NV S.A.V.E. when they are offline.
- f. Finally, the members discussed whether the number of registrants and users is as anticipated and how the numbers differed from expectations. Nathan Branscome and Chief of Staff Teresa Benitez-Thompson

discussed how the one thing that had Sylogist stand out from other vendors was the ability to track an offender for the life of their crimes and incarcerations, instead of having to reregister for every incident, which was causing 2-3 times the number of registrants than there actually were. Nevada had just under 37,000 registrants at go-live with numbers rising steadily as data was cleaned up and word of the new system got out to the public. Reports are being built out and will be discussed in the NV S.A.V.E. governance subcommittee.

5. **For Discussion and Possible Action:** Review, discussion and possible approval of the *June 16, 2025, Meeting Minutes*.
 - a. Approved unanimously.
6. **For Information Only:** Ombudsman Jamie Trevino will give a quick update on progress made by the subcommittees.
 - a. The Membership subcommittee met and discussed the new requirements in statute about membership within the CDVSA committee. Members are drafting letters and a press release seeking resumes and letters of interest for open positions and for a recommitment from current members, along with availability.
 - b. The NV S.A.V.E. Governance subcommittee has been struggling to hit quorum for their first meeting, but Ombudsman Trevino asked for updated availability from those sitting on the subcommittee to dive deeper into the impacts of the new notification system and what reports are needed for data collection.
 - c. The FRT subcommittee is coming back into compliance by creating bylaws and connecting with each jurisdiction to determine what cases can be reviewed and how the reports will function in the future.
7. **For Discussion:** Committee members will discuss with local community members and stakeholders the issues surrounding Domestic Violence and Sexual Assault that are prevalent within their community.
 - a. Some of the major issues being seen within Domestic Violence and Sexual Assault in Winnemucca and Humboldt County are:
 - Required jury trials and not having a big enough room to hold these trials so cases are backed up months or longer
 - Judicial training on victim services and DV/SA trials
 - Mental health services are lacking for first responders
 - So many federal grants are shrinking that programs are losing people, and we are losing services.

- b. Committee members discussed VOCA and VAWA issues and where we see grant funding going in the next few years. Liz Ortenburger, CEO of SafeNest, discussed triaging high risk victims that could potentially lead to homicides, using lethality assessments, focusing on who owns guns vs. strangulations within the community in order to maximize dwindling funds with the biggest impact.

Domestic Violence, Sexual Assault, and Human Trafficking Quarterly Report

Quarter 3 – 2025

NRS 228.450 Duties; confidentiality of certain information collected in discharge of duties; use of grants to compensate.

1. The Ombudsman for Victims of Domestic Violence, Sexual Assault and Human Trafficking shall:
 - (a) Prepare quarterly reports relating to victims of domestic violence, sexual assault and human trafficking from information collected from the Central Repository for Nevada Records of Criminal History, if any such information is available.
 - (b) Provide necessary assistance to victims of domestic violence, sexual assault and human trafficking.
 - (c) Provide education to the public concerning domestic violence, sexual assault and human trafficking, including, without limitation, the prevention of domestic violence, sexual assault and human trafficking, available assistance to victims of domestic violence, sexual assault and human trafficking, and available treatment for persons who commit domestic violence, sexual assault and human trafficking.
 - (d) Perform such other tasks as are necessary to carry out the duties and functions of his or her office.
2. Except as otherwise provided in this subsection, information collected pursuant to paragraph (a) of subsection 1 is confidential and must not be disclosed to any person under any circumstances, including, without limitation, pursuant to a subpoena, search warrant or discovery proceeding. Such information may be used for statistical purposes if the identity of the person is not discernible from the information disclosed.
3. Any grant received by the Office of the Attorney General for assistance to victims of domestic violence, sexual assault and human trafficking may be used to compensate the Ombudsman for Victims of Domestic Violence, Sexual Assault and Human Trafficking.
