- a. SafeNest has a planning retreat coming up in February to discuss the opening of One Safe Place in Las Vegas with one day for planning sessions and one day for breakout focus groups. The center's soft opening is in June and ribbon cutting at the end of October.
- b. Kathleen Thimsen DNP, MSN, WOCN/CETN, FNS, DF-AFN, AFN-BC, discussed the SANE trainings coming up at UNLV in conjunction with UNR in late May/June. Las Vegas crime lab met with Kathleen and forensic nurses to discuss and create a non-strangulation SANE kit. There is also a forensic training coming up in October.
