### **1. Call to Order and Roll Call.**

  - *Christopher Hicks moved to approve the minutes of the August 29, 2023 meeting. John Jones seconded the motion. The minutes were approved unanimously of the voting members, with Tyler Ingram abstaining.*
  
4. **Discussion on status of the 2023 Prosecutors Conference and possible vote to continue, postpone, or cancel the conference for 2023. (For possible action).**
  - *Chair Ford stated that the conference agenda as written was not commensurate with the expectations of the Advisory Council. Christopher Hicks asked if it can be postponed to September 2024, the traditional time for the annual conference. Homa Woodrum explained the contracting terms relating to postponement, and stated that such a postponement could be an option for the Advisory Council.*
  - *Carly Helbert states that lots of planning was done by those planning to attend the conference, including courts clearing their calendars for the conference.*
  - *Chair Ford asked Michael Morton to provide an update on conference attendance, which Michael Morton stated had dropped significantly due to various district attorney and city attorney offices dropping out of the conference.*
  - *Chris Hicks provided comments as to why this meeting was taking place and why various offices had concerns related to the conference's programming.*
  - *Homa Woodrum stated a concern related to the Open Meeting Law, regarding bringing up the character or professional conduct of a person who had not been provided proper notice of the meeting.*
  - *Chris Hicks moved to postpone the conference to September 2024. Tyler Ingram seconded the motion.*
  - *In discussion, Chair Ford stated reasonable minds can disagree, and defended portions of the conference agenda.*
  - *Carly Helbert voted no on the motion to postpone the conference. The rest of the members of the Advisory Council in attendance voted yes. Motion passed.*
