Activities

While interning with the Attorney General's Office, Legal Interns may participate in and experience:

- Meet & Greet with Attorney General Aaron Ford
- Nevada Courts
- Nevada Legislature
- Administrative hearings before state agencies, boards, or commissions
- Nevada prison tour

Opportunities to Observe

Legal Interns may also have opportunities to observe Deputy Attorneys General prosecuting cases, at mediations or settlement conferences, and advising state agencies, boards, and commissions on administrative law.

Hands-On Experience

Legal Interns rank their substantive areas of interest and are matched to available Office divisions. Interns are given meaningful legal assignments under the supervision of one or more seasoned Deputy Attorneys General. Legal Interns also receive opportunities to seek additional feedback and guidance from attorney mentors outside of their supervisory chain.

Examples of hands-on experiences include:

- Researching and writing legal memos and briefs
- Attending court appearances, assisting attorneys preparing for appellate and other oral arguments
- Drafting litigation-related documents such as motions and discovery requests
- Updating guidance for state agencies by incorporating recently enacted legislation
- Preparing documents for use by clients, state agencies, and law enforcement
- Participating in outreach efforts to educate the general public

Internship positions are volunteer only, but academic credit may be available.

Training

Legal Interns attend an orientation and workshops about the legal services the Office provides. When available, interns also attend trainings provided by other entities. Each intern receives a developmental plan that outlines the type of assignments they will work on, specific learning goals, meetings and other events to attend, and other learning opportunities as well as their responsibilities and obligations.

Feedback & Reflection

Legal Interns meet regularly with their supervising attorneys, or as a group, to discuss their tasks and experiences. At the conclusion of the internship, interns fill out an exit survey and participate in an exit interview to provide feedback.
