21 contrary to the form, force and effect of statutes in such cases made and provided, and
22 against the peace and dignity of the State of Nevada, committed the following offense:

23 **COUNT I**

24 **OBTAINING AND USING PERSONAL IDENTIFYING INFORMATION
FOR AN UNLAWFUL PURPOSE**

25 **A Category B Felony in Violation of NRS 205.463**

26 DEFENDANT MEGAN MARIE KLEIN, on or between the dates of June 20, 2013,
27 and January 16, 2014, within Carson City, Nevada, did knowingly, willfully and
28 unlawfully obtain and use the personal identifying information of another person with the
intent to commit an unlawful act. More specifically, DEFENDANT MEGAN MARIE


All of which is contrary to the form, force and effect of the statutes in such cases, made and provided, and against the peace and dignity of the State of Nevada.


