24 ADAM PAUL LAXALT, Attorney General, and ROSS E. ARMSTRONG, Deputy
25 Attorney General, in the name and by the authority of the State of Nevada, inform the above
26 entitled court that DREMA SUE SMITH, contrary to the form, force and effect of statutes in such
27 cases made and provided and against the peace and dignity of the State of Nevada, committed
28 the following offense:

29 **ATTEMPTED THEFT**

30 (A Category D Felony / Gross Misdemeanor in violation of NRS 205.0832(1)(c), NRS
31 205.0835(3), & NRS 193.330(1)(a)(4))

32 That the said defendant, DREMA SUE SMITH, individually and/ or in joint participation
33 with another, within Washoe County, Nevada, did knowingly and without lawful authority
34 attempt to obtain property or services from another person by a material misrepresentation,

1 with intent to deprive that person of the property or services, in the following manner: that on,
2 about, or between January 31, 2012 and December 31, 2012, the defendant attempted to
3 obtain Unemployment Compensation benefits for KYLE JASON GABELMAN in an
4 approximate amount more than \$650.00 but less than \$3,500.00 from the Nevada
5 Unemployment Security Division, and made material misrepresentations by failing to inform
6 the Division that KYLE JASON GABELMAN was incarcerated in the Washoe County
7 Detention Facility and/ or the Nevada Department of Corrections and thus not eligible for said
8 benefits.
