21 **AMENDED CRIMINAL INFORMATION**

22 ADAM PAUL LAXALT, Attorney General, and ROSS E. ARMSTRONG, Deputy  
23 Attorney General, in the name and by the authority of the State of Nevada, inform the above  
24 entitled court that KYLE JASON GABELMAN, contrary to the form, force and effect of statutes in  
25 such cases made and provided and against the peace and dignity of the State of Nevada,  
26 committed the following offense:

27 **THEFT**

28 (A Category C Felony in violation of NRS 205.0832(1)(c) & NRS 205.0835(3))

That the said defendant, KYLE JASON GABELMAN, within Washoe County, Nevada,  
did knowingly and without lawful authority obtain property or services from another person by  
a material misrepresentation, with intent to deprive that person of the property or services, in  
the following manner: that on or between January 31, 2012 and December 31, 2012, the

1 defendant obtained Unemployment Compensation benefits in a value more than \$650 but less  
2 than \$3,500 from the Nevada Unemployment Security Division, and made material  
3 misrepresentations by failing to inform the Division that KYLE JASON GABELMAN was  
4 incarcerated in the Washoe County Detention Facility and/ or the Nevada Department of  
5 Corrections and thus not eligible for said benefits.

6 **AFFIRMATION PURSUANT TO NRS 239B.030**
