18 **INDICTMENT**

20 Defendants, ALAN RODRIGUES, JONAS BOWEN, LARRY SMITH, WILLIAM
21 HARPER, JOZSEF MATE, and TRACY JONES, above named, are accused by the grand jury
22 of having committed the following offenses:

23 THEFT IN THE AMOUNT OF \$3500 OR MORE, VICTIM 60 YEARS OF AGE OR
24 OLDER, a category "B" felony in violation of NRS 205.0832(1) and 193.167; THEFT IN THE
25 AMOUNT OF \$650 OR MORE, VICTIM 60 YEARS OF AGE OR OLDER, a category "C"
26 felony in violation of NRS 205.0832(1) and 193.167; and MULTIPLE TRANSACTIONS
27 INVOLVING FRAUD OR DECEIT, a category "B" felony, in violation of NRS 205.377.

28 All of the acts alleged herein have been committed or consummated on or between

1 August 2013 and July 2014, by the above-named Defendants, executed in whole or in part
2 within the County of Clark, State of Nevada, in the following manner:

5 **THEFT IN THE AMOUNT OF \$3500 OR MORE, VICTIM 60 YEARS OF AGE OR**
6 **OLDER**

7 **Category "B" Felony - NRS 205.0832(1); 205.0835; 193.167**

8 Defendants ALAN RODRIGUES, JONAS BOWEN, LARRY SMITH, WILLIAM
9 HARPER, JOZSEF MATE, and TRACY JONES, in the County of Clark, State of Nevada,
10 either by virtue of their own actions or by the actions of their agents or employees, without
11 lawful authority, knowingly controlled property of another person with intent to deprive that
12 person of the property; and/or converted, made an unauthorized transfer of an interest in, or
13 without authorization controlled property of another person, or used the property of another
14 person entrusted to him or placed in his possession for a limited, authorized period of
15 determined or prescribed duration of for a limited use; and/or obtained property of another
16 person by a material misrepresentation with intent to deprive that person of the property, and

18 On or between August 1, 2013 and September 30, 2013, Defendants ALAN

21 under one or more of the following principles of criminal liability, to-wit: (1) by directly
22 committing this crime; and/or (2) by aiding or abetting in the commission of this crime, with
23 the intent that this crime be committed, by providing counsel and/or encouragement and by
24 entering into a course of conduct whereby ALAN RODRIGUES, JONAS BOWEN, and

4 misrepresented that the Defendants and/or World Travel Access would transfer Karen
5 McCarthy's two (2) timeshare properties in World Travel Access's ownership in exchange for
6 an upfront fee. Relying on that misrepresentation, Karen McCarthy paid to LARRY SMITH
7 and/or World Travel Access approximately \$6,332. However, neither the Defendants nor World
8 Travel Access ever actually attempted to transfer ownership of a timeshare for Karen
9 McCarthy, nor have they refunded Karen McCarthy's money. Karen McCarthy was 60 years of
10 age or older at the time of Defendants' actions.

11 All of which constitutes the crime of THEFT IN THE AMOUNT OF \$3,500 OR MORE,
12 VICTIM 60 YEARS OF AGE OR OLDER, a category "B" felony in violation of NRS
13 205.0832(1) and 193.167.

22 lawful authority, knowingly controlled property of another person with intent to deprive that
23 person of the property; and/or converted, made an unauthorized transfer of an interest in, or
24 without authorization controlled property of another person, or used the property of another
25 person entrusted to him or placed in his possession for a limited, authorized period of
26 determined or prescribed duration of for a limited use; and/or obtained property of another

On or about May 29, 2014, Defendants ALAN RODRIGUES, JONAS BOWEN,

19 of a timeshare for William Shunney, nor have they refunded William Shunney's money.
20 William Shunney was 60 years of age or older at the time of Defendants' actions.

21 All of which constitutes the crime of THEFT IN THE AMOUNT OF \$3,500 OR MORE,
22 VICTIM 60 YEARS OF AGE OR OLDER, a category "B" felony in violation of NRS
23 205.0832(1) and 193.167.

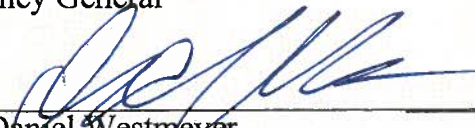
