That the said defendant, YOHANNES HABTEMICAEL, within Washoe County, State of Nevada, on or about August 19, 2014, to on or about November 30, 2015, did knowingly and unlawfully, after having been appointed as guardian of a person over 60 years of age, exploit that person by converting money, assets and/or property with a value of over \$5,000, with the intention ///
