**AMENDED CRIMINAL
INFORMATION**

ADAM PAUL LAXALT, Attorney General of the State of Nevada, and AMANDA SAGE, Deputy Attorney General, in the name and by the authority of the State of Nevada, inform the above-entitled court that JUSTIN MENDOZA, contrary to the form, force and effect of statutes in such cases made and provided, and against the peace and dignity of the State of Nevada, committed the following offense:

COUNT I

BATTERY BY A PRISONER WITH THE USE OF A DEADLY WEAPON

Category "B" Felony - NRS 200.481(2)(g)(1)

That the Defendant, JUSTIN MENDOZA, a prisoner in the lawful custody of the Nevada Department of Corrections, did willfully and unlawfully use force or violence upon the person of another, with the use of a deadly weapon, to wit:

On or about April 11, 2017, MENDOZA, while incarcerated at Lovelock Correctional Center pursuant to a Fourth Judicial District Court Judgment of Conviction in Case No. CR-FP-11-0772, stabbed the neck of Michael Pope using a sharpened metal ballpoint pen, at or near 1200 Prison Road in Lovelock, Pershing County, Nevada, 89419.


1 All of which is contrary to the form, force and effect of the statutes in such cases, made
2 and provided, and against the peace and dignity of the State of Nevada.
