17 ADAM PAUL LAXALT, Attorney General of the State of Nevada, and AMY K.
18 STEELMAN, Deputy Attorney General, in the name and by the authority of the State of
19 Nevada, inform the above-entitled court that NANETTE LAELI PEA, contrary to the form,
20 force and effect of statutes in such cases made and provided, and against the peace and
21 dignity of the State of Nevada, committed the following offense:

22 COUNT I

23 ATTEMPTED FURNISHING CONTROLLED SUBSTANCE TO STATE PRISONER

24 Category "C" Felony - NRS 193.330 & 212.160

25 That the Defendant, NANETTE LAELI PEA, did knowingly and without
26 authorization by law attempt to furnish to a prisoner confined in an institution of the
27 Department of Corrections, or any other place where prisoners are authorized to be or are
28 assigned by the Director of the Department, a controlled substance, to wit:

1 On or about August 27, 2017, the Defendant knowingly and without authorization
2 by law, attempt to furnish methamphetamine, a schedule I controlled substance, to a
3 prisoner confined at Northern Nevada Correctional Center, at or near 1721 East Snyder
4 Avenue, Carson City, Nevada.

5 All of which is contrary to the form, force and effect of the statutes in such cases,
6 made and provided, and against the peace and dignity of the State of Nevada.
