16 CRIMINAL INFORMATION

17 ADAM PAUL LAXALT, Attorney General of the State of Nevada, and AMY K.
18 STEELMAN, Deputy Attorney General, in the name and by the authority of the State of
19 Nevada, inform the above-entitled court that LEMUELU PATA SAUNI, contrary to the
20 form, force and effect of statutes in such cases made and provided, and against the peace
21 and dignity of the State of Nevada, committed the following offense:

22 COUNT I

23 TRAFFICKING IN A SCHEDULE I CONTROLLED SUBSTANCE,

24 FOUR TO FOURTEEN GRAMS

25 Category "B" Felony – NRS 195.020 & 453.3385(1)(a)

26 That the Defendant, LEMUELU PATA SAUNI, did aid and abet, counsel, encourage,
27 hire, command, induce, or otherwise procure NANETTE IAELI PEA to knowingly or
28 intentionally actually or constructively possess a controlled substance which is listed in

1 schedule I, except marijuana, or a mixture which contains any such controlled substance,
2 in a quantity of four (4) grams or more, but less than fourteen (14) grams, to wit:

3 On one or more occasions on or between May 27, 2017, and August 27, 2017, SAUNI
4 asked or directed PEA to obtain methamphetamine, a schedule I controlled substance,
5 and/or SAUNI arranged for \$600.00 to be sent to PEA for the purpose of obtaining
6 methamphetamine, and on August 27, 2017, PEA did actually possess a baggie containing
7 approximately seven (7) grams of methamphetamine or a mixture of containing
8 methamphetamine, at or near 1721 East Snyder Avenue, Carson City, Nevada.


9 All of which is contrary to the form, force and effect of the statutes in such cases,
10 made and provided, and against the peace and dignity of the State of Nevada.


