CRIMINAL INFORMATION

14 ADAM PAUL LAXALT, Attorney General of the State of Nevada, and TIRZAH
15 MATHEWS, Senior Deputy Attorney General, in the name and by the authority of the State
16 of Nevada, inform the above-entitled court that SHERI HINES, contrary to the form, force
17 and effect of statutes in such cases made and provided, and against the peace and dignity of
18 the State of Nevada, committed the following offense:

19 COUNT I

20 **EMBEZZLEMENT**

21 **Category "B" Felony - NRS 205.300 and NRS 205.0835**

22 That the defendant, SHERI HINES, within Douglas County, State of Nevada, did
23 knowingly, willfully and unlawfully, as a person with whom money had been entrusted, used
24 the money in a manner that was different than the purpose for which it was entrusted, said
25 property valued in excess of \$3,500, to wit: On or about January 2017 to on or about June
26 2017, the Defendant, having been entrusted with the checkbook and/or debit card for a
27 bank account belonging to Sharon Mayes for the purpose of paying Sharon Mayes' bills
28 and/or providing for her care and comfort, did use or appropriate \$3,500 or more from

1 Sharon Mayes' bank accounts by using ATM machines in Wa She Shu Casino and/or
2 Sharkey's Casino located in Douglas County, Nevada, and used the funds for purposes other
3 than paying Sharon Mayes' bills and/or providing for her care and comfort.

4 All of which is contrary to the form, force and effect of the statutes in such cases, made
5 and provided, and against the peace and dignity of the State of Nevada.
