INSURANCE FRAUD

(Category D Felony - NRS 686A.281 to NRS 686A.295, inclusive)

Defendant, SOJOURNER T. DANYAL MARABLE, did without lawful authority, knowingly and willfully present or cause to be presented any statement as a part of, or in support of, a claim for payment or other benefits under a policy of insurance, knowing that the statement conceals or omits facts, or contains false or misleading information concerning any fact material to that claim; and/or act or fail to act with the intent of defrauding or deceiving an insurer, a reinsurer, a producer, a broker or any agent thereof, to obtain any proceeds or other benefits under a policy of insurance; and/or accept any proceeds or other benefits under a policy of insurance knowing that the proceeds or other benefits are derived from any of the foregoing acts or omissions; and/or participate in, assist, aid, abet, solicit or conspire with another person to present or cause to be presented any statement to an insurer, a reinsurer, a producer, a broker or any agent thereof, knowing that the statement conceals or omits facts, or contains false or misleading information concerning any fact material to a claim for payment or other benefits under a policy of insurance, or any of the foregoing acts or omissions, to wit:

The above-named defendant presented a false insurance claim to State Farm Mutual Automobile Insurance Company, under claim number 28-7N66-944, claiming that on November 21, 2015, she was hit by a motor vehicle driven by the insured, Tameka Nicole Green, when in truth and in fact, the accident never occurred. As a result, \$7,500 was accepted from State Farm Mutual Automobile Insurance Company.
