20 **CONSENT JUDGMENT**

21 Plaintiff State of Nevada, by and through Aaron D. Ford, Attorney General (“the
22 State”), and defendant Apple Inc., a corporation (“Defendant” or “Apple”) have stipulated
23 to and consent to the Court’s entry of this Consent Judgment (“Judgment”) in this
24 proceeding and accept this Judgment as the final adjudication of this civil action without
25 taking proof and without trial, without this Judgment constituting evidence of or an
26 admission by Defendant regarding any issue of law or fact alleged in the Complaint,
27 without Defendant admitting any liability, and with all parties having waived their right
28 to appeal.

1 This Judgment is entered to resolve the investigations of Defendant undertaken by
2 the Attorneys General of the states and commonwealths of Alaska, Arizona, Arkansas,
3 California, Connecticut, Florida, Hawaii¹, Idaho, Illinois, Indiana, Iowa, Kansas,
4 Kentucky, Louisiana, Michigan, Minnesota, Missouri, Montana, Nevada, Nebraska, New
5 Jersey, North Carolina, North Dakota, Ohio, Oregon, Pennsylvania, South Carolina,
6 Tennessee, Texas, Utah, Vermont, Virginia, Wisconsin, and the District Of Columbia (the
7 “Attorneys General” or “States”) pursuant to each of the States’ respective Consumer
8 Protection Laws, including unfair and deceptive acts or practices statutes.

9 **I. PARTIES**

- 10 1. Plaintiff is the State of Nevada, by and through Aaron D. Ford, Attorney
11 General.
12 2. Defendant is Apple Inc., a company with its principal office located in
13 Cupertino, California.

14 **II. JURISDICTION AND VENUE**

- 15 3. Apple, at all relevant times, has transacted business in the State of Nevada,
16 including but not limited to business in Clark County, Nevada.
17 4. This Court has jurisdiction over the Complaint and the parties necessary for
18 the Court to enter this Judgment and any orders hereafter appropriate.
19 5. Venue is proper in Clark County, Nevada.
20 6. This Judgment is entered pursuant to and subject to the Nevada Revised
21 Statutes (“NRS”) 598.0903, et seq. (the “Nevada Deceptive Trade Practices
22 Act”).
23 7. Apple accepts and expressly waives any defect in connection with service of
24 process in this action issued to Apple, and further consents to service upon the
25 below-named counsel via e-mail of all process in this action.

26 ¹ Hawaii is represented by its Office of Consumer Protection. For simplicity purposes, the entire group
27 will be referred to as the “Attorneys General,” or individually as “Attorney General.” Such designations,
28 however, as they pertain to Hawaii, shall refer to the Executive Director of the Office of Consumer
Protection, a division of the Department of Commerce and Consumer Affairs.

III. CONSENT TO JUDGMENT

8. Defendant acknowledges that it has waived service of the Summons and Complaint, has read this Judgment, and is aware of its right to a trial in this matter and has waived the same.
9. Defendant admits the jurisdiction of this Court and consents to the entry of this Judgment.
10. Defendant states that no promise of any kind or nature whatsoever was made to induce it to enter into this Judgment and declares that it has entered into this Judgment voluntarily.
11. This Judgment is entered as a result of a compromise and a settlement agreement between the parties. Only the parties to this action may seek enforcement of this Judgment. Nothing herein is intended to create a private right of action by other parties; however, this Judgment shall not limit the rights of any private party to pursue any remedies allowed by law.
12. Defendant acknowledges that its acceptance of this Judgment is for the purpose of settling the ongoing consumer fraud lawsuit filed by the State.
13. This Consent Judgment may be executed in counterparts and be delivered by facsimile or electronic transmission, or a copy thereof, such constituting an original counterpart hereof, all of which together will constitute one and the same document.
14. Defendant represents and warrants that the individual signing below on its behalf is duly appointed and authorized to do so.

IV. DEFINITIONS

15. "Clear and Conspicuous" means that statements, disclosures, or other information, by whatever medium communicated, including all electronic devices, are (a) in readily understandable language and syntax, and (b) in a type size, font, color, appearance, and location sufficiently noticeable for a

1 consumer to read and comprehend them, in a print that contrasts with the
2 background against which they appear.

3 16. “Consumer Protection Laws” means the consumer protection laws enforced by
4 the Attorneys General under which the Attorneys General have conducted the
5 investigation as set forth in Appendix A.

6 17. “Covered Conduct” means Apple’s business practices, acts and omissions,
7 including its representations and disclosures, related to Performance
8 Management in Relevant iOS Versions between 2016 and the Effective Date.

9 18. “Effective Date” means November 25, 2020.

10 19. “iOS” means the operating system software made available by Apple for
11 iPhones and other mobile devices.

12 20. “iPhone” means the personal devices designed and marketed by Apple.

13 21. “Performance Management” means the functionality first introduced in iOS
14 10.2.1 for managing the performance of the Relevant iPhones to match the
15 peak power delivery of lithium-ion batteries.

16 22. “Person” means any natural person or the person’s legal representative,
17 partnership, domestic or foreign corporation, company, trust, business
18 entity, or association, and any agent, employee, salesperson, partner, officer,
19 director, member, stockholder, associate or trustee of the same.

20 23. “Relevant iOS Versions” means all iOS versions between iOS 10.2.1 and
21 11.2.6, inclusive.

22 24. “Relevant iPhones” means the iPhone models relevant to the States’ claims,
23 which are as follows:

- 24 a. iPhone 6;
- 25 b. iPhone 6 Plus;
- 26 c. iPhone 6S;
- 27 d. iPhone 6S Plus;
- 28 e. First generation iPhone SE;

- f. iPhone 7; and
- g. iPhone 7 Plus.

V. INJUNCTIVE RELIEF

- 25. The injunctive provisions of this Judgment shall apply to Apple and its directors, officers, employees, representatives, agents, affiliates, parents, subsidiaries, predecessors, assigns and successors and shall be effective for three (3) years from the Effective Date of this Judgment.
- 26. Apple will maintain easily accessible and prominent webpage(s) that provide Clear and Conspicuous information to consumers about lithium-ion batteries, unexpected shutdowns, and Performance Management. The webpage(s) will provide guidance to consumers on steps they can take to maximize battery health. The webpage(s) will also describe the operation of Performance Management and its impact on iPhone battery and performance.
- 27. If a future iOS update materially changes the impact of Performance Management when downloaded and installed on an iPhone, Apple will notify consumers in a Clear and Conspicuous manner of those changes in the installation notes for the update.
- 28. Apple will provide information to consumers in the iPhone user interface (e.g., Settings > Battery > Battery Health) about the battery, such as the battery's maximum capacity and information about its peak performance capability, as well as a notification of the option to service the battery once the performance of the battery has become significantly degraded.
- 29. Apple will implement procedures to ensure its consumer-facing staff and Apple-authorized iPhone retailers:
 - a. are sufficiently familiar with the information in the webpage(s) described in paragraph 26 and the iPhone user interface described in paragraph 28;
 - b. communicate such information to consumers wherever relevant; and
 - c. refer consumers to such webpage(s) or interface, where appropriate.

1 **VI. DISPUTE RESOLUTION**

2 30. If one or more Attorneys General reasonably believe that Apple has failed to
3 comply with any term of the injunctive relief, each Attorney(s) General shall,
4 collectively or individually, provide written notice to Apple, unless the
5 failure to comply threatens the health or safety of the citizens of their
6 state(s) and/or creates an emergency requiring immediate action. Apple
7 shall have sixty (60) days from receipt of such notice to provide a good faith
8 written response, including either a statement that Apple believes it is in
9 full compliance with the relevant provision or a statement explaining how
10 the violation occurred, how it has been addressed or when it will be
11 addressed, and what Apple will do to make sure the violation does not occur
12 again. The Attorney(s) General may agree to provide Apple with more than
13 sixty (60) days to respond. During the sixty (60) day period, each of the
14 Attorney(s) General shall engage in good faith discussions with Apple before
15 taking any enforcement action(s), in an attempt to resolve the alleged non-
16 compliance. If Apple notifies the Attorneys General in writing that two or
17 more Attorneys General have notified Apple of alleged violations, the
18 Attorney(s) General that provided notice of alleged violations shall engage in
19 those good faith discussions collectively if possible.

20 31. Nothing herein shall be construed to exonerate any contempt or failure to
21 comply with any provision of this Judgment after the date of its entry, or to
22 prevent the Nevada Attorney General in this action from initiating a
23 proceeding for any contempt or other sanctions for failure to comply, or to
24 compromise the authority of a court to punish as contempt any violation of
25 this Judgment. Further, nothing in paragraph 30 shall be construed to limit
26 the authority of the Nevada Attorney General in this action to protect the
27 interests of Nevada.

28 ///

VII. MONETARY PAYMENT

32. Apple shall pay a total of One Hundred and Thirteen Million Dollars (\$113,000,000.00) to the Attorneys General, to be apportioned amongst the Attorneys General at their sole discretion. The amount apportioned to the Nevada Attorney General, \$1,577,469.41, is to be paid by Apple directly to the Nevada Attorney General. The wiring instructions shall be provided to Apple no later than seven (7) days after the Effective Date. If the Court has not entered this Judgment by the Effective Date, Apple shall make the payment within sixty (60) days of the Effective Date or within thirty (30) days of the entry of the Judgment, whichever is later. Said payment to the Nevada Attorney General shall be used and designated by and in the sole discretion of the Nevada Attorney General and shall be used for reimbursement of attorney fees and other costs of investigation; distributed or applied to any applicable consumer protection enforcement funds, including future consumer protection enforcement, consumer education, litigation or local consumer aid, or revolving funds; defraying the costs of the inquiry leading hereto, or for any other lawful purpose, at the sole discretion of the Nevada Attorney General. Upon completion of the wire transfer described above, Apple shall have no further obligation to assist Nevada in its use of its portion of the payment.

33. Also out of the total amount due to the Attorneys General set forth in paragraph 32, Apple will make a single payment on behalf of and at the direction of the States, within sixty (60) days of the Effective Date, to funds maintained in trust by the National Association of Attorneys General, in an amount designated and communicated to Apple by the Arizona Attorney General.

VIII. RELEASE

- 1
2 34. By its execution of this Judgment, Nevada releases and forever discharges
3 Apple and its past and present directors, officers, employees,
4 representatives, agents, affiliates, parents, subsidiaries, predecessors,
5 assigns and successors (“Releasees”) from any and all civil causes of action or
6 claims for damages, costs, attorneys’ fees, or penalties of any kind that the
7 Attorneys General have asserted or could have asserted concerning the
8 Covered Conduct. The Attorneys General execute this release in their official
9 capacity and release only claims that the Attorneys General have the
10 authority to bring or release. Nothing contained in this paragraph shall be
11 construed to limit the ability of the Nevada Attorney General to enforce
12 Apple’s obligations under this judgment.
- 13 35. Notwithstanding any term of this Judgment, specifically reserved and
14 excluded from the release in paragraph 34 as to any entity or Person,
15 including the Releasees, are any and all of the following:
16 a. any criminal liability that any Person or entity, including Releasees, has
17 or may have to the States;
18 b. any civil or administrative liability that any Person or entity, including
19 Releasees, has or may have to the States under any statute, regulation or
20 rule giving rise to any and all of the following claims;
21 i. state or federal antitrust violations;
22 ii. state or federal securities violations; or
23 iii. state or federal tax claims.
- 24 36. Nothing in this Judgment shall be construed as excusing or exempting Apple
25 from complying with any applicable state or federal law, rule, or regulation,
26 and no provision of this Judgment shall be deemed to authorize or require
27 Apple to engage in any acts or practices prohibited by any state or federal
28 law, rule, or regulation.

1 IX. GENERAL PROVISIONS

2 37. The provisions of this Judgment shall be construed in accordance with the
3 laws of Nevada.

4 38. Nothing in this Judgment shall be construed as an approval by the Attorneys
5 General or any state agency of Apple's past, present, or future conduct.

6 39. Apple shall not represent or imply that the Attorneys General, the State of
7 Nevada, or any state agency has approved or approves of any of Apple's
8 actions or past, present, or future business practices.

9 40. This Judgment shall not bar the Nevada Attorney General or any other
10 governmental entity from enforcing applicable laws, regulations, or rules
11 against Apple for conduct subsequent to the Effective Date or otherwise not
12 covered by this Judgment.

13 41. Apple willingly has entered into this Judgment in order to resolve the
14 Attorney General's claims under the Nevada Deceptive Trade Practices Act,
15 NRS 598.0903, et seq., as to the matters addressed in this Judgment and
16 thereby avoid significant expense, inconvenience, and uncertainty.

17 42. Apple has entered into this Judgment solely for the purposes of settlement,
18 and nothing contained herein may be taken as or construed to be an admission
19 or concession of any violation of law, rule, or regulation, or of any other matter
20 of fact or law, or of any liability or wrongdoing, all of which Apple expressly
21 denies. No part of this Judgment, including its statements and commitments,
22 shall constitute evidence of any liability, fault, or wrongdoing by Apple. This
23 document and its contents are intended to be used in resolving this litigation
24 and not by any other party or for any other purpose.

25 43. This Judgment shall not be construed or used as a waiver or limitation of any
26 defense otherwise available to Apple in any other action, or of Apple's right to
27 defend against, or make any agreements in, any private individual action,
28 class claims or suits, or any other governmental or regulatory action relating

1 to the subject matter or terms of this Judgment. Notwithstanding the
2 foregoing, the Nevada Attorney General may file an action to enforce the
3 terms of this Judgment.

4 44. No part of this Judgment shall create, waive, release or limit a private cause
5 of action or confer any right to any third party for a violation of any state or
6 federal statute.

7 45. The exclusive right to enforce any violation or breach of this Judgment shall
8 be with the parties to this Judgment and the Court.

9 46. Nothing in this Judgment constitutes an agreement by the State of Nevada
10 concerning the characterization of the amounts paid hereunder for purposes
11 of any proceeding under the Internal Revenue Code or any state tax laws. The
12 Judgment takes no position with regard to the tax consequences of the
13 Judgment with regard to federal, state, local, and foreign taxes.

14 47. This Judgment is binding upon the State of Nevada and Apple, and any of
15 Apple's respective successors, assigns, or other entities or persons otherwise
16 bound by law.

17 48. Apple agrees that this Judgment does not entitle it to seek or to obtain
18 attorneys' fees as a prevailing party under any statute, regulation, or rule,
19 and Apple further waives any right to attorneys' fees that may arise under
20 such statute, regulation, or rule.

21 49. If any provision of this judgment is found to be invalid or unenforceable, the
22 provision will be enforced to the maximum extent permissible by law to
23 effectuate the intent of the parties, and the remainder of this judgment will
24 continue in full force.

25 50. This Judgment represents the entire agreement between the parties, and
26 there are no representations, agreements, arrangements, or understandings,
27 oral or written, between the parties relating to the subject matter of this
28 Judgment not fully expressed herein or attached hereto.

1 51. Jurisdiction is retained by the Court for the purpose of enabling any party to
2 the Judgment to apply to the Court at any time for such further orders and
3 directions as may be necessary or appropriate for constructing this
4 Judgment's terms, for modifying any of the injunctive provisions, for enforcing
5 compliance, and for punishing violations, if any.

6 52. This Judgment becomes effective upon entry, which is ordered forthwith. No
7 notice of entry of judgment is required to be served upon Defendant.

8 53. This Judgment resolves all outstanding claims expressly identified in the
9 Complaint filed in the above captioned matter. As no further matters remain
10 pending, this is a final judgment.

11 54. Any notices or other documents required to be sent to the Parties pursuant to
12 this Judgment shall be sent to the following addresses via first class and
13 electronic mail, unless a different address is specified in writing by the party
14 changing such address:
