16 **AMENDED CRIMINAL INFORMATION**

17 AARON D. FORD, Attorney General of the State of Nevada, and ALISSA C. ENGLER, Senior
18 Deputy Attorney General, in the name and by the authority of the State of Nevada, inform the above-entitled
19 court that NICHOLAS VERLON DYKES contrary to the form, force and effect of statutes in such cases
20 made and provided, and against the peace and dignity of the State of Nevada, committed the following
21 offenses within Washoe County, Nevada:

22 **COUNT 1**
COERCION

23 **Category "B" Felony – NRS 207.190(1)**

24 That on or about February 17, 2020, Defendant, NICHOLAS VERLON DYKES, did willfully,
25 unlawfully, and feloniously, use physical force, or immediate threat of such force against S.G., with the
26 intent to compel S.G. to do or abstain from doing an act which she had a right to do or abstain from doing,
27 to wit: by using force or immediate threat of force upon S.G. in order to compel her to engage in
28 prostitution.

COUNT 2
PANDERING
Category "C" Felony – NRS 201.300(1)

That on or about February 17, 2020, Defendant, NICHOLAS VERLON DYKES, did willfully, unlawfully and feloniously induce S.G. to become a prostitute and/or continue to engage in prostitution.
